WORKSHOP

- 1. Approval of Agenda.

- 5. Event Application (1945 Dade County Fair Nathan Wooten) Mr. Nathan Wooten presented the event application, asking the City to co-sponsor by providing street closure between the pool and basketball courts at Jenkins Park and the side street leading up to the Civic Center. Plans are to have an antique car show in the parking lot of the Civic Center. Also, by providing the use of the Civic Center and the Swimming Pool for the date of July 3rd. Mr. Wooten has spoken with his insurance agent and will be providing liability coverage for the event and will make sure that each vendor has a liability policy as well.
- 6. Civic Center reopening the Civic Center since the Governor has lifted the ban on gatherings. Mayor Case and Commissioner Powell will form new procedures and a contract for rental as soon as possible.
- 7. Election IGA Dade County Board of Elections will conduct the City Election to be held in November in conjunction with Dade County's Special Election to fill the vacancy of Commissioner Allan Bradford. The City will conduct qualifying at City Hall. Early Voting, Absentee Voting, and Election Day will be held at the Dade County Commission Building. The City will pay for the writing of the software for the City Election and will pay one half of the other costs associated with conducting the November 2021 election.
- Property Tax Collections Appalachian Mountain Services, Inc. conducts tax collections for Dade County. They approached the City and wanted to collect delinquent taxes for the City as well. They will charge the City for the mailing of the first letter sent, then after all costs from the agency will be added to the tax bill and paid to them when collected.
- Ordinance No. 2021-01 Broadband Ready Community The NWG Regional Commission met and discussed the need for being a broadband ready community. This ordinance is a template from the Regional Commission allowing the City of Trenton to be broadband ready for future developments and technology.

Commissioner Wooten announced she would have the signup sheets along with the release forms and yellow safety vests the day of the events.

Mayor Case reported he was able to attend the grand opening of Tractor Supply. The financial reports were read by Mayor Case for the month of March 2021.

Marshana Sharp with Dade County Public Library reported on a grant they have received and built a new kitchen and they will be starting up the summer reading program. William Back was absent, but Mayor Case reported meeting with him and others and discussing a new site for the industrial park that will require the sewer department to increase the amount they can handle.
