In consideration of these services, and as an express condition thereof, owner/client agrees to waive any and all claims against A DOG'S DAY OUT unless arising from gross negligence on the part of A DOG'S DAY OUT.</p> <p>Owner/client represents dog as being in good health and free of any communicable diseases.</p> <p>A DOG'S DAY OUT will not be held responsible for clipper bum and/or minor nicks resulting from grooming of matted, neglected coats, or for irritation caused by removing coat from pets possessing mild to severe skin allergies, nor will we be held responsible for stressful effects grooming may have upon an elderly pet.</p> <p>EVERY attempt will be made to groom your pet as discussed with Groomer, but in the case of severely matted coat, the Groomer will make an attempt to notify owner before taking further action. If owner is unavailable at the time of call, the Groomer, at her/his discretion will do what is best/most comfortable for your pet.</p>	<p>WE reserve the right to charge additional fees for services we consider over and above the norm covered by our standard rates. We also reserve the right to refuse service to customers whose pet may pose a threat to us or to the other pets left in our care, whether it is an aggression problem, health problem, or parasite problems.</p> <p>OWNER agrees to be responsible for any property damages by pet.</p> <p>A DOG'S DAY OUT does its best to be as careful as possible. There may be times when a dog is slightly injured due to sudden movements. Owner/client understands and accepts these risks.</p> <p>IN the event of a more serious injury, after all necessary attempts to reach Owner/client fails, Owner/client authorizes A DOG'S DAY OUT to seek medical attention at the Vet.</p> <p>IN the event the dog shows aggressive behavior and A DOG'S DAY OUT cannot finish the grooming for fear of injury, Owner/client agrees to remain responsible for all applicable charges whether work is completed or not. If we cannot begin work, we will return the dog to you with no charge.</p> <p>THIS agreement will remain valid for all future grooming services.</p>
