

ORDINANCE NO. 2024-4

AN ORDINANCE TO AMEND CHAPTER 12.06 OF THE MUNICIPAL CODE OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, RELATING TO SEWER USER CHARGES.

THE VILLAGE BOARD OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

SECTION I. Chapter 12.06 the Sewer User Charge System section 4(e) of the Village of Boaz shall be and hereby is amended to read as follows:


(4) RESIDENTIAL EQUIVALENCY CHARGE

* * * *

“(e) The residential equivalency charge (REC) shall be \$55.00 per month for users who do not provide electricity for the grinder pump used by them and \$52.50 per month for users who do provide such electricity.”

SECTION II This ordinance shall be effective January 1, 2025, after adoption and posting, as provided by law.
