

**ORDINANCE NO. 2025-1**

**AN ORDINANCE TO AMEND SECTION 5.12 BURN ORDINANCE OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, RELATING TO BURN PERMITS.**

THE VILLAGE BOARD OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

**SECTION I.** Section 5.12 of the municipal code of the Village of Boaz shall be and hereby is amended to read as follows:


**“5.12 BURNING RESTRICTED.** No person shall kindle any fire within the Village without first securing a written permit from the Village Clerk, any Village Trustee, or the Department of Natural Resources. This section shall not apply to any fire kindled in a fire pit not exceeding three (3) feet in diameter, burn barrel, outdoor furnace, gas grill or charcoal grill unless the fire exceeds a flame height of six (6) feet, in which case a burn permit shall be required.”

**SECTION II.** This ordinance shall be effective the day after its passage and posting as required by law.
