DO ORDAIN AS FOLLOWS:


SECTION I. Subsection (C), Paragraph (2), of Ordinance No. 2017-2, the All-Terrain Vehicle and Utility Terrain Vehicle Operation and Routes Ordinance of the Village of Boaz, shall be and hereby is amended to read as follows:

(C) Designation of All-Terrain Vehicle and Utility Terrain Vehicle Routes.

Under the authority of Wis. Stat. ss. 23.33(11)(am)4, the Village of Boaz also designates State Trunk Highway 171 and County Highway E within the territorial boundaries of the Village of Boaz and with a posted speed limit of 35 miles per hour or less.


SECTION III. This ordinance shall be effective January 11, 2018.
