

ORDINANCE NO. 2018-2

AN ORDINANCE TO AMEND ORDINANCE NO. 2017-2 (THE ALL-TERRAIN VEHICLE AND UTILITY TERRAIN VEHICLE OPERATION AND ROUTES ORDINANCE) OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, RELATING TO DESIGNATION OF ATV/UTV ROUTES

THE VILLAGE BOARD OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

SECTION I. Subsection (C), Paragraph (2), of Ordinance No. 2017-2, the All-Terrain Vehicle and Utility Terrain Vehicle Operation and Routes Ordinance of the Village of Boaz, shall be and hereby is amended to read as follows:

(C) Designation of All-Terrain Vehicle and Utility Terrain Vehicle Routes.

Under the authority of Wis. Stat. ss. 23.33(11)(am)4, the Village of Boaz authorizes the operation of ATVs on State Trunk Highway 171 and County Highway E within the territorial boundaries of the Village of Boaz and with a posted speed limit of 35 miles per hour or less.

Under Wis. Stat. ss. 23.33(4)(d)3.b. and 11(am)3., the Village of Boaz designates WIS 171 as an ATV route from the Town of Dayton boundary to Jefferson Street to connect with the Town of Dayton's designation of WIS 171 from USH 14 to the Village of Boaz's boundary in order to cross the bridge over the east branch of Mill Creek.

SECTION III. This ordinance shall be effective September 13, 2018.
