

ORDINANCE NO. 2018-4

AN ORDINANCE ESTABLISHING PARK REGULATIONS IN THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN

THE VILLAGE BOARD OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section 1: The following regulations are hereby established for use of the Boaz Community Park:

1. The Park is hereby closed from 11 p.m. until 5 a.m. every day of the week except for special event days as approved by the Village Board.
2. The speed limit in the Park shall be 15 miles per hour.
3. Theft or damage to any Park property is hereby prohibited.
4. Trail bikes, dune buggies, motorcycles, etc. shall not be operated inside the Park boundaries. Horse unloading and riding shall be done north of the Community Building and in the horse arena.
5. No person shall discharge or cause a discharge of any missile, including paintballs, pellet gun, slingshot, bow and arrow, firearm or other weapon within Park or, except as may otherwise be allowed by law, within 200 yards of said Park. The launch of model rockets is permitted.
6. No person shall light any fire in the Boaz Community Park, unless the fire is ignited in the receptacles such as grills and contained fire rings provided for that purpose, or in those portable grills brought to the Park by Park users where those grills are made for the purpose of containing fires and preparing food.
7. The parking of heavy trucks requires pre-approval of the Village Board
8. Park events are scheduled by appearing at a meeting of the Village Board.


Section 2: Penalties

Any person violating any provision of this ordinance shall, upon conviction, forfeit to the Village no more than \$100.00 and costs incurred by the Village in the prosecution of the violation of this Ordinance.

Section 3: Repeal of Prior Ordinances


This ordinance repeals any ordinance inconsistent with the terms hereof.
