
AN ORDINANCE TO REPEAL AN ORDINANCE OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, ADOPTED JANUARY 8, 1979, AND RELATED TO THE PARKING AND LOCATION OF MOBILE HOMES AND THE LICENSING AND REGULATION OF MOBILE HOME PARKS AND CAMPS
