AN ORDINANCE REPEALING ORDINANCE NOS. 3, 5, 6, 9, 12 AND AN UNNUMBERED ORDINANCE PERTAINING TO TAVERN HOURS IN THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN

THE VILLAGE BOARD OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section I: The following Ordinances of the Village of Boaz shall be and the same hereby are repealed:

Ordinance No. 3 entitled An Ordinance Establishing Hours of Business for Taverns (incorrectly dated 1/5/69 but adopted 1/5/70)

Ordinance No. 6 entitled An Ordinance to Cope with Defense Emergencies (adopted 1/5/70)

Ordinance No. 9 entitled An Ordinance Establishing a Code of Ordinances (adopted 1/5/70)

Ordinance No. 5 entitled An Ordinance Regulating and Governing House Trailers and Mobile Homes (adopted 5/4/70)

Unnumbered Ordinance Regulating the Business Hours of Taverns (adopted 11/17/84)

Ordinance No. 12 entitled An Ordinance Creating and Establishing a Park Committee for the Village of Boaz, Richland County, Wisconsin (adopted 11/8/95)


Section II: This ordinance shall take effect upon the passage and posting of this ordinance or a notice of adoption of this ordinance as provided by law.
