

ORDINANCE NO. 2020-2

AN ORDINANCE AMENDING ORDINANCE NO. 01 RELATED TO ALCOHOL BEVERAGE LICENSING FEES IN THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN.

WHEREAS, the COVID-19 pandemic has created financial hardships for business owners, including owners of licensed premises in the Village; and

WHEREAS, the Village Board of the Village of Boaz has determined that it is reasonable to alleviate such hardship for certain license holders by temporarily reducing certain license fees;

NOW, THEREFORE, THE VILLAGE BOARD OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section I: The following fees related to intoxicating liquor and fermented malt beverages as provided under Ordinance No. 01 are hereby modified as follows:

(3) License Fees. There shall be the following classes of licenses, which, when issued by the Village Clerk under the authority of the Village Board after payment of the specified fee, shall permit the holder to sell, deal or traffic in alcohol beverages as provided in the Wisconsin Statutes.

(c) Class "B" Fermented Malt Beverages/Beer License (see Sec. 125.26(4) of Wis. Stats.) License fee shall be one dollar (\$1.00) for the license year commencing July 1, 2020, which fee shall be prorated according to the number of months or fraction thereof for which the license is issued.

(d) "Class B" Intoxicating Liquor License (see Sec. 125.51(3) of Wis. Stats.) License fee shall be fifty dollars (\$50.00) for the license year commencing July 1, 2020, or fraction thereof. The license fee for a reserve "Class B" license as defined under Wis. Stat. sec. 125.51(4)(a)4. shall be \$10,000 per year.

(h) Operators' Licenses (see Sec. 125.17 of Wis. Stats.) License fee shall be one dollar (\$1.00) for the license year commencing July 1, 2020, or fraction thereof.

Section II: This ordinance shall take effect upon its passage and publication or posting as required by law. This ordinance shall sunset on March 1, 2021, unless sooner repealed.
