

ORDINANCE NO. 2021-1

AN ORDINANCE RELATED TO THE KEEPING OF SWINE IN THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN

THE VILLAGE BOARD OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section I. No person may own, harbor or keep swine on any property in the Village of Boaz except as follows:

- (A) Any person owning or occupying a property of at least one (1) acre but less than two (2) acres in size may own, harbor or keep one (1) swine on the property.
- (B) Any person owning or occupying a property of at least two (2) acres in size may own, harbor or keep up to two (2) swine on the property.


Section II. For purposes of this ordinance, the following definitions shall apply:

- (A) "Swine" means any pig, boar or hog, whether wild or domestic, excluding the subspecies of *sus scrofa* commonly known as pot-bellied pigs weighing less than 80 pounds.
- (B) "Property" means parcels of land contiguous to one another and owned or occupied by the same person or a person and/or legal entities in which the same person has a legal interest (e.g., partnership, trust, limited liability company or similar entities). The presence of roads or driveways does not affect contiguity.

Section III. Any person, firm, or corporation who violates, disobeys, neglects, omits or refuses to comply with this ordinance shall, upon conviction, forfeit not less than \$50.00 nor more than \$250.00 together with the cost of prosecution and, in default of payment of such forfeiture and cost of prosecution, shall be imprisoned in the County Jail of Richland County until said forfeiture and costs are paid not to exceed 30 days for each violation. Each day that a violation continues to exist shall constitute a separate offense. Any violation of this ordinance shall be deemed a public nuisance and may be enforced as such in any manner provided by law.

Section IV: This ordinance shall take effect upon its passage and posting as required by law.
