

ORDINANCE NO. 2022-1

**AN ORDINANCE TO AMEND THE SEWER USE AND USER CHARGE ORDINANCE OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, RELATING TO CERTAIN SEWER CHARGES**

THE VILLAGE BOARD OF THE VILLAGE OF BOAZ, RICHLAND COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

SECTION I. Article VI, Paragraph 4, of the Sewer Use and User Charge Ordinance of the Village of Boaz shall be and hereby is amended to read as follows:

1) RESIDENTIAL EQUIVALENCY CHARGE

\* \* \* \*

“The Residential Equivalency Charge (REC) shall be \$50.00 per month for users who do not provide electricity for the grinder pump used by them and \$47.50 per month for users who do provide such electricity....”

SECTION III. This ordinance shall be effective January 1, 2023.
