

## ORDINANCE No. 550

### **An Ordinance of the Municipal Code of the City of Kiel Repealing and Recreating Fair and Open Housing**

The Common Council for the City of Kiel do ordain as follows:

SECTION 1: Section 18.10 is repealed and recreated to now read as follows:

#### FAIR AND OPEN HOUSING.

1) STATE STATUTES ADOPTED.

- a. The Common Council of the City of Kiel hereby adopts Section 106.50, Wisconsin Statutes, as amended, and all subsequent amendments thereto.

2) AUTHORITY AND ENFORCEMENT PROCEDURES IMPLEMENTED:

- a. The officials and employees of the City of Kiel shall assist in the orderly prevention and removal of all discrimination in housing within the City of Kiel by implementing the authority and enforcement procedures set forth in Section 106.50, Wisconsin Statutes, as amended.

3) SEC. 13-3-3 COMPLAINTS.

- a. The City Administrator/City Clerk shall maintain forms for complaints to be filed under Section 106.50, Wisconsin Statutes, as amended, and shall assist any person alleging a violation thereof in the City of Kiel to file a complaint thereunder with the Wisconsin Department of Workforce Development, Equal Rights Division, for enforcement of Section 106.50, Wisconsin Statutes, as amended.


SECTION 2: This ordinance shall take effect upon passage and publication in accordance of law.


