2025 TOURNAMENT RULES - OPEN Division

1. This tournament is open to all bowlers who are currently sanctioned in the **Greater Richland USBC Association** and have participated in a minimum of 21 games in one league prior to the time of bowling in the tournament.
2. Teams will have a playing strength of four with no gender requirements. Entrants may bowl more than once only in the **Team** event in the OPEN division, subject to the following conditions:
 - a. Must not compete in the tournament with more than one team from the same league.
 - b. Must choose which **Team** event will be used in the **All Events** category before the entry closing date of Jan. 17, 2025. See the option on the entry form labeled as the **AE Team Option**.
3. Entrants may bowl only once in the **Doubles** and **Singles** events in the OPEN division.
4. Entrants must enter the **Doubles** and **Singles** events to compete in the **Scratch Singles** option. Entrants must enter the **Handicap All Events** to compete in the **Scratch All Events** option. Entrants do not have to enter the **Scratch Singles** event to compete in the in **Scratch All Events** option.
5. Entry fees are non-refundable. Cash prizes will be awarded for all the events.
6. All entrants are subject to:
 - a. The average adjustment requirements of USBC Rule 319C.
 - b. Reporting prior prize winnings in tournaments requirement of USBC Rule 319D.
7. Handicap for this tournament will be based only on games bowled in **Greater Richland USBC** Association leagues. Handicap for the tournament will be assigned in this order:
 - a. If the bowler’s current average is 15 or more pins higher than last season’s average, the current season’s average will be used.
 - b. The bowler’s highest (21-game minimum) average from last season will be used.
 - c. The bowler’s highest (21-game minimum) average from this season will be used.
 - d. If none of these conditions apply, an average of **230** will be assigned.
8. The tournament will use a straight handicap method. Handicap for the **Team** event will be 90% of the difference between **920** and the sum of the team’s averages. Handicap for the **Doubles** and **Singles** events will be 90% of the difference between **230** and the bowler’s average.
9. Team captains must check in at least 30 minutes before squad time and report all substitutions to the tournament manager at that time.
10. It is each bowler’s responsibility to verify the accuracy of his average.
11. Any bowler or team arriving after the game has started will be allowed to bowl and scores will count in the frames bowled. Zero scores will be given for frames missed.
