Waiver and Release of Liability

READ BEFORE SIGNING

In consideration of being permitted to participate in paintball and airsoft activities under the auspices of Allstarr Paintball & Airsoft, I agree as follows:

I fully understand and acknowledge that:

1. Risks and dangers exist in my use of paintball equipment and my participation in paintball activities. Those risks include but are not limited to: permanent disability, death, bodily injury, disease, strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, frostbite, and other ailments. While protective equipment and personal discipline will minimize this risk, the risk does exist.
 2. These risks and dangers may arise from foreseen and unforeseeable causes and circumstances. These risks and dangers may be caused by the negligence of Allstarr Paintball & Airsoft owners, employees, officers and agents; the negligence of the participants; the negligence of others; accidents, breaches of contracts, the forces of nature or other causes.
 3. By my participation in these activities, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the persons associated with Allstarr Paintball & Airsoft or by any other person.
 4. I understand that the activities associated with paintball and airsoft are physically and mentally intense. I understand the rules of play and will comply with all rules and regulations. If I observe any hazard during my participation, I will bring it to the attention of the nearest official as soon as is practical.
 5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless from liability Allstarr Paintball & Airsoft (and all such persons associated including but not limited to owners, employees, officers, agents), with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releases or otherwise.

 - Allstarr Paintball & Airsoft reserves the right to inspect any and all bags at any time.

I understand and agree that this Release of Liability covers each and every paintball or airsoft activity and event in which I participate for up to 1 year from the date it is signed (unless otherwise specified). I have read the above waiver and release and by signing it agree it is my intention to exempt and relieve Allstarr Paintball & Airsoft from liability for personal injury, property damage or wrongful death due to negligence or any other cause. For participants of minority age (Under 18 at time of signing), I certify that I, the parent or guardian with legal responsibility for this participant, do consent and agree to the release of Allstarr Paintball & Airsoft for the participant. I also agree to release and indemnify Allstarr Paintball & Airsoft from any and all liabilities incident to the participant's involvement in these activities to myself, my heirs, assigns, and next of kin.
