## Rotary Club of Springfield Sunrise Obligations of Membership

### Costs:

- Initiation Fee.....\$115
- Dues.....\$114 semi-annually
- Meals .....\$416 semi-annually
- Guest Assessment.....\$6 semi-annually

*Meal Policy:* No credit is given for missed meetings, excess meal funds go to projects fund. The meal charge is \$16 per meal.

*Special Events:* Extra charges may be separately billed to those participating in special dinners or activities such as the Installation Banquet and Christmas Party.

*Rotary Foundation:* It is recommended that each member participates in EREY (Every Rotarian Every Year) and makes at least a \$100 contribution to the Rotary Foundation on an annual basis.

A Rotarian may be dropped from membership for failure to promptly pay dues or assessments.

### Attendance Rules:

- Members must maintain at least 60% attendance during the first and second six months of the club's fiscal year.
- Membership is subject to termination if the member misses four consecutive meetings.
- Members have the following opportunities to make-up a missed meeting 2 weeks before or after the absence:
  - Attendance at another Rotary meeting. Meeting locations in the area are published in the *Sunriser*. Meeting locations throughout the world are available from the Club Secretary.
  - Attendance at the regular board meeting held on the 3<sup>rd</sup> Wednesday of each month.
  - Attendance at any other Rotary related event or meeting.
