Residential zoning permit fee is \$.22 per square foot of living, basement, garage, decks, patios, porches, and attics with headroom's and any man made structure as defined in Tunkhannock Township Zoning Ordinance 2012-127. To simplify accounting the **balance due will be requested when the permit is complete and can be paid when permit is picked up. The Zoning Officer has thirty (30) days from date of submittal to approve a permit application.
