

Department 6E Exhibition Booths – Youth R 2018

Please review "Exhibit Information - General Rules and Information." See "Main Menu - Calendar" for entry schedule.

1. Organization must be registered as exhibitor to receive premium money.
2. Exhibits must be completed and ready for judging by 5:00 pm Tuesday, 2 days before Fair start.
3. The exhibit shall be removed Sunday, immediately following Fair closure, between the hours of 8:00 AM and 5:00 PM.
4. Exhibits previously entered in the Fair are not eligible for premiums.
5. Exhibit booths are approximately 8 ft. X 8 feet; only one booth for each exhibit.
6. Fire codes and safety precautions will be observed at all times.
7. Exhibits shall be maintained and kept in good condition throughout the Fair.
8. 4-H Clubs:
 - A. 4-H Club general guidance:
 1. Exhibits prepared by professional decorators or exhibit makers will not qualify for premiums or ribbons. This does not prohibit sign painters or artists for lettering or decorations incidental to the main theme, or the use of commercially made mannequins or other properties.
 - B. 4-H Club booth judging will be based on the following:
 1. Power to attract attention
 2. Power to arouse and hold interest of viewer
 3. The main idea of the exhibit is educational, worthwhile, distinctive, and significant
 4. Extent to which exhibit creates interest in the idea, project, or practice portrayed or recommended
 5. Success in relating the exhibit to 4-H activities in the community
 6. General appearance, attractiveness, arrangement, and neatness
9. FCCLA:
 - A. FCCLA general guidance:
 1. All work should be done by FCCLA members or FACS classes.
 2. If supplies are donated, recognition can be given.
 3. School exhibits can be from Family and Consumer Science Classes and FCCLA.
 - B. FCCLA booth judging will be based on the following:

1. Power to attract attention
2. Power to arouse and hold interest of viewer
3. The main idea of the exhibit is educational worthwhile, and significant
4. Exhibit should create interest in the idea, project or practice portrayed
5. Relate FCCLA Club activities in the community
6. General appearance should be neat and attractive

10. FFA

A. FFA general guidance:

1. No professional printing or painting in exhibits; work must be done by FFA members and Vocational Agriculture Students
2. If supplies or professional help are donated, recognition should be given.
3. FFA student exhibits should display field, orchard, garden, forestry, animal products, basic trades and the like. Concepts, ideas and management may be used.

B. FFA booth judging will be based on the following:

1. Power to attract attention
2. Power to arouse and hold interest of viewer
3. The main idea of the exhibit is educational worthwhile, and significant
4. Extent to which exhibit creates interest in the idea project, or practice portrayed or recommended
5. Success in relating the exhibit to FFA Club activities in the community
6. General appearance, attractiveness, arrangement neatness

11. Awards: All entries will receive \$125 Ribbons will be awarded for 1st, 2nd and 3rd place overall, not by division.
