Seven Pines

Grant Update

Briglia reviewed the Progress Report submitted to Ashley Shultz, Department of Conservation and Natural Resources for the Seven Pines Phase 1B Development Grant. The Progress Report included a summary of the project accomplishments, challenges and needs related to the approved scope of work; a list of key actions and target dates related to the approved scope of work and project completion; and a list of all incurred costs (cash and/or non-cash) related to the approved scope of work to date.

Ice Lake

Ice Lake Trail

Briglia stated that Patti O'Keefe had contacted Gary Konrath, Paradise Township Board of Supervisors Chair, and volunteered to complete the trail at Ice Lake that was approved to be completed by Brian Kurtz (East Stroudsburg University Student). The Commission was under the impression that the trail had been completed. Briglia stated that she would contact Patti O'Keefe to attend the next PARC meeting to discuss the trail.

Skywood Park

Sled Riding

Briglia stated that the sled riding hill is being used weather permitting.

Ice Rink

Hilfiger was not in attendance for an update. Beers reported that Pocono Township recently installed an ice skating rink behind the War Memorial along Route 611 in Tannersville and that Stroudsburg Township has an ice skating rink behind North Fifth Street.

Other Business/Public Comment

Barry inquired if PARC has received the completed financial statement from Zavada and Associates for 2017. Briglia will follow up with Zavada and Associates, as well as obtain quotes from other CPA's to complete the 2018 financial statement.
