December 11, 2024

Resolution # 122 - Minutes

Supervisor Campbell asked for a resolution to approve the November 6th & 13th, 2024, minutes. Councilmember Travis made the resolution to approve minutes seconded by Councilmember Smith.

Resolves that the November 13, 2024, minutes are accepted as submitted.

Resolution # 123 - Supervisor Report November 2024

December Supervisor report was distributed and discussed. Supervisor Campbell asked for a resolution to approve the Supervisor report as submitted. Councilmember Harman made the resolution to approve the Supervisor report, seconded by Councilmember Carey.

Councilmember Harman made the resolution to approve the bills/vouchers as presented, seconded by Councilmember Travis.

Parks & Recreation – Playground Project Update

Highway Superintendent provided an update on the Playground project. An agreement has been signed with Josh Landscape and the project is scheduled for late spring / early summer of 2025.

Resolution #127 – Highway Report

Highway Superintendent Ball submitted the November-December 2024 Highway report.

Supervisor Campbell asked for a resolution to approve the Highway Report.

Councilmember Carey made the resolution to approve the November-December 2024 Highway report, seconded by Councilmember Smith.

Resolves that the November-December 2024 Highway report is accepted as presented.

Supervisor Campbell provided an update to Highway that the American Rock Salt pricing was recently reduced.

Highway Superintendent Ball provided the Town Board with a current equipment inventory for the highway department. Supervisor Campbell asked for updates on equipment availability and the status of electric trucks. Highway Superintendent Ball advised that valid information on the subject has been hard to find and validate. The Board had a general discussion on the requirements and abilities of potential electric truck requirements.

Highway Superintendent Ball asked about the potential of dumping “ditching” at the old town dump site. Supervisor Campbell advised he would look into this and provide an answer to Superintendent Ball.

Councilmember Carey asked how the jointly owned equipment (shoulder machine) program is working, Highway Superintendent Ball advised it is working.

Councilmember Travis asked about the potential resources for going through the code files. Town Clerk Thompson had provided a report/spreadsheet to the Town Board and CEO for the single family dwellings that are showing open in the Code Office system, the Town Board has at the last meeting had asked for these to be made a priority for review. Town Clerk Thompson has pulled each available file and provided and update on the statue of the Certificate of Occupancy for each. Supervisor Campbell is working with the State on guidelines and guidance for closing files. Councilmember Harman would like to see a timeline/plan for clearing up the Code Office files/system. Supervisor Campbell is working with the Town of Richmond to update the contract.
