### Town Hall

Supervisor Campbell advised the Board that Attorney Hou is working with the surety and the Town has quotes for finishing the seeding and grading but we are waiting for the surety to approve before any work is done. He also advised the Board that he has been in contact with the Bond Agent regarding renewing the BAN which would push the payment out until next year.

Supervisor Campbell asked if any of the guests had questions or comments.

Corey Keyes advised the Board that the Church will be holding a drive in service by way of a radio transmitter on Father's Day, and that Joel Steele will be running a chicken barbeque in the parking area that day.

Corey and Teresa Keyes and Wayne Roberts all expressed concerns about the cell tower construction.

The generator, co-location of the tower, whether the correct process was followed and communications were discussed.

Supervisor Campbell advised them that he will look into all of their concerns. He added that the Town Attorney and Town Engineer have been involved in the process and that the DEC and EPA regulations apply as well. The Planning Board will respond to their concerns.
