Now, therefore, be it resolved that the Town Superintendent of Highways is authorized to purchase, in accordance with the provisions of Article 5-A of the General Municipal Law, the following:

(1)2021 Ford F250 with plow frame

For the maximum price of \$34,750.00

Delivered at 2560 County Road 37, West Bloomfield NY by 12/31/2021.

The Town Superintendent of Highways is authorized to sell the following equipment at auction at an estimated price of \$30,000.00.

(1)2019 Blue Ford F250 with 8 foot plow.

A contract for the item purchased shall be duly executed between the Town Superintendent of Highways and such vendor. When the contract has been executed and upon delivery of the item purchased, the Supervisor shall pay the following amounts as specified:

(1)2021 John Deere 310L Loader Backhoe with a 4 in one bucket and a Sweepster 9' angle broom

For the maximum price of \$123,000.00

Delivered at 2560 County Road 37, West Bloomfield NY by 12/31/2021.

The Town Superintendent of Highways is authorized to trade the following equipment at an estimated price of \$34,000.00.

(1)2011 Case 580N Loader Backhoe

A contract for the item purchased shall be duly executed between the Town Superintendent of Highways and such vendor. When the contract has been executed and upon delivery of the item purchased, the Supervisor shall pay the following amounts as specified:

\$0.00 from budgetary appropriation for the purchase of equipment  
\$89,000.00 from the proceeds of obligations issued pursuant to the Local Finance Law for a 36 month lease with the first payment to be in March 2022.

\$35,086.00 from budgetary appropriation for the purchase of equipment  
\$0.00 from the proceeds of obligations issued pursuant to the Local Finance Law.
