Supervisor Todd Campbell called the Town Board meeting to order at 7:00pm

Resolution # 17 - Minutes

Supervisor Campbell asked for a resolution to approve the January 11, 2023, Town Board Meeting Minutes. Councilman Harman made the resolution to approve minutes seconded by Councilman Carey. Privilege of the Floor

Andy Toombs from the Ionia Volunteer Fire Department provided information on discussions being held at the Ionia Fire Department regarding the Town's Emergency Plan. He presented the possibility of the Ionia Fire Department being designated as an Emergency Preparedness Facility. There was discussion on updating the Town's Emergency Plan be a combined effort with the Town Board, West Bloomfield Fire Department, Ionia Fire Department, American Legion Post 282, and area Churches. <u>Resolution #23 - 2022/2023 Municipal Snow and Ice Agreement Supplemental Agreement and Adjustment/Calculation</u>

Whereas the Town of West Bloomfield is under contract # D014811, with the New York State Department of Transportation to provide snow and ice control on specified State roads within the Town and Now, therefore, be it resolved, to authorize the Highway Superintendent to execute the present NYS Snow & Ice Agreement and Adjustment/Calculation for 2022/2023. The current Contract is Valid from 7/1/2019 to 6/3/2024. Councilman Harman made the resolution to approve the 2022/2023 Municipal Snow and Ice Agreement Supplemental Agreement and Adjustment/Calculation, seconded by Councilman Travis.
