### **Supervisor Todd Campbell called the Town Board meeting to order at 7:03pm**

#### **Resolution #75 - Minutes**

Supervisor Campbell asked for a resolution to approve the July 12, 2023, Town Board Meeting Minutes. Councilman Travis made the resolution to approve minutes seconded by Councilman Carey. Adopted: Ayes – Campbell, Carey, Travis, Harman - Nays, None  
Resolves that the July 9, 2023, minutes are accepted/approved as presented.

#### **Resolution #76 - Supervisor Report**

The Supervisor's Report dated August 5, 2023, was distributed, and discussed. Supervisor Campbell asked for a resolution to approve the submitted Supervisor report. Resolves that the Supervisor's report dated August 5, 2023, is accepted as presented. Supervisor Campbell commented: Sales Tax is on track for the year, and DASV funding paid down the bond anticipation note.

#### **Resolution # 78 Vouchers – Payment of Bills**

Councilman Carey provided an overview on the smoke machine that was purchased by the West Bloomfield and Ionia Fire Departments as part of the collaboration spend (SL1-3410.45).

- Truck Purchases – Estimated pricing for 2023 on a 1ton truck is \$68,500.00, 8% increase is expected for 2024, total including stainless steel dump bed estimated at \$106,000.00. Truck to be ordered for 2024 budget.
- One estimate received to pave the Town Hall Parking lot - \$9,217.75

**Insurance** – Supervisor Campbell provided information on the current insurance policy for the Town, currently with Steele Agency. The quote went from \$22,000.00 to 28,000.00 without the needed Cyber Policy. A quote was received from NYMIR for \$25,000.00, provides better coverage. The Board agreed that Supervisor Campbell should move forward with moving the insurance policy from Steele Agency to NYMIR.

**Councilman Travis** – provided a report sheet on A & DA budget spend. Supervisor Campbell provided updates on the items outlined in the report.
