Below is a few details regarding contract information to follow:

- All changes to wedding contracts or wedding transactions must be handled with a bridal consultant.
- The bride/individual signing this contract is the only person permitted to authorize, submit and change any arrangements for the wedding party.
- Please inform all bridal party members of information included on contract
- For our safety and yours, any breaches of this contract will be resolved through the bride/individual who signed this contract.

Payments:

- All prices noted above are base prices. Therefore each stylist has the direction to charge as they see fit.
- Prices increase to variables such as length, thickness, texture, difficulty, etc.
- Blow dry charges can be added for damp hair on the morning of the wedding.
- Additional charges for work with extensions.
- Wedding parties booked on any observed holidays will have cost discrepancies.
- Gratuity is NOT included on any pricing.

In-Salon

- Deposits made hold all appointments made for the day of your wedding.
- This amount is per person reserved on each contract. The amount will be deducted from each guest's final amount owed on the wedding day.
- A single deposit per person withholds a "reservation" for that single bridal party's appointment. If for any reason a cancellation occur this amount can not be applied towards any other owed amounts
- Appointments will not be "locked-in" until the full deposit amount is paid in full per appointment.
- Any add-ons made after the consultation date must be paid in full.
- Remaining balances will be paid on the wedding date and paid in full.
- City Limits Hair Studio and Day Spa accepts cash and credit ONLY for all wedding transactions.
- We reserve the right to book any other parties or appointments of deposits that have not been paid in full.

Destination/holiday-Two installments:

- First installment due at time of booking (half down.)
- Second installment due at 60 day cut off date. (remaining balance.)
- All services must be paid in full on the day of booking.
- City Limits Hair Studio and Day Spa accepts cash and credit (venmo) ONLY for all wedding transactions.
- CASH ONLY FOR HOLIDAYS.

Destination Travel Fee:

- Prices are based on a staff of 2-3 Stylists (prices will increase with the need of more staffing.)
- Prices based off Mapping starting at City Limits Hair Studio (will be provided)
- These amounts include travel expenses, product usage and time.

Wedding Enhancements

City Limits Hair Studio & Day Spa happily offers many services for you and your wedding party. This includes: Manicures, Pedicures, Facials, Massage, hair coloring, Haircuts, Waxing, and more!

Pretrial Sessions

- We suggest having your pretrial session at least 1 week prior to your wedding. It is very important for you and your stylist to get an idea for the day of your wedding.
- Reminder to bring any hairpieces, veils, etc. along with you that day for styling purposes.
- Pricing will be similar to the prices on the wedding day but can vary due to similar additions.
- Provide photos, examples of ideas for make-up/style

On Your Day:

- Entire party must arrive 15 minutes BEFORE your scheduled appointment time. Any tardiness will not be tolerated and may result in a late fee and/or appointment loss.
- Hair must be clean and dry.
- Remember All Accessories (veils, flowers, headpieces, tiara, etc.)
- Be sure to have all bridal party members wear button-down tops.
- Make sure your face is cleansed and moisturized prior to arrival at our salon to ensure that make-up holds all day long.

Credit Card Authorization:

For our protection and yours, City Limits Hair Studio & Day Spa asks to keep a credit card on file to reserve all appointments for you and your bridal party. City Limits Hair Studio & Day Spa will keep all of this information strictly confidential.
