MEMBERSHIP CLASS DEFINITIONS AND FEE SCHEDULES

Initiation Fees are paid as follows:

Senior Voting: Adults 21 years of age or older, single or married, with voting rights and Club privileges extending to their immediate families including unmarried children up to 25 years of age. Family units of one senior voting membership shall be entitled to one vote.

- \$500 paid in full with this application. A separate payment for the first month's dues is also required at the time of approval.

Single Voting: Adults 21 years of age or older, single, without a spouse or children, with voting rights and Club privileges extending only to that individual. Single voting members shall be entitled to one vote. Upon marriage, Single Members are required to convert to Senior Voting.

- \$500 paid in full with this application. A separate payment for the first month's dues is also required at the time of approval.

Service: Members of officer rank in the United States Armed Services who are on active duty in the vicinity of Pascagoula, Mississippi, with single or family privileges as described above. These members shall have no voting privileges.

- \$300 paid in full with this application. A separate payment for the first month's dues is also required at the time of approval.

Non-Resident: Adults 21 years of age or older, single or married, residing outside of Jackson County, Mississippi, with single or family privileges as described above. These members shall have no voting privileges.

- \$400 paid in full with this application. A separate payment for the first month's dues is also required at the time of approval.

Legacy Definition: Dependents of a current member who is in good standing and has been a member continuously for the past 5 years.

- **Legacy Senior:** \$300 paid in full with this application. A separate payment for the first month's dues is also required at the time of approval.
- **Legacy Single:** \$300 paid in full with this application. A separate payment for the first month's dues is also required at the time of approval.
- **Legacy 21-24:** \$300 paid in full with this application. A separate payment for the first month's dues is also required at the time of approval.

Reinstatement: May upon approval become a Reinstated member with the reduced initiation fee. Reinstated Members are also obligated to pay ***\$300 for the 2018 Assessment if not previously paid. A separate payment for the first month's dues is also required at the time of approval.
