Applicant will be responsible for mailing fees of certified notices. Notifications will be prepared and provided by the Planning & Zoning office to the applicant. Notifications shall be sent at least fifteen (15) days prior to the Planning Commission scheduled meeting.

**SUBMITTAL DEADLINE:**

Application, proof of certified notification mailing and required items as identified in Zoning Resolution Article III, Section 3.060 shall be submitted no later than 2 weeks prior to the regularly, scheduled Planning Commission meeting to be eligible for placement on the agenda.
