

EMPOWERING futures through scholarships

DCG Education Foundation gears up for annual event.

Those involved with the DCG Education Foundation know firsthand the power of community support. The organization is a 501(c)3 nonprofit on a mission to raise scholarship funds for DCG seniors pursuing higher education.

"While independent from the DCG Community School District, we do work together to educate our students, staff and community at large," Tiffany Hamil, president of the foundation, shares. "To date, we have distributed over \$1 million in scholarship funds."

The foundation's efforts are driven by a variety of fundraising events, the most prominent being the annual Raising Education Dollars (RED) Dinner and Auction. This November marks the seventh year of the event.

Held on Saturday, Nov. 2 from 5-9 p.m. at Three Sisters Barn in Dallas Center, RED brings the community together for a fun night of games, a meal, a live auction and, most importantly, the opportunity to raise funds for four-year renewable scholarships.

"We currently offer three scholarships but have lofty goals to increase that year over year," Hamil says. "It can only be done by getting participants to raise their paddles high."

Ahead of the event, the foundation offers an online silent auction that's available to the community at large.

Hamil emphasizes that every dollar raised directly impacts the students.

"It's simple. The more we raise, the more we can give," she says.

The RED event is vital for continuing the foundation's mission of reducing financial barriers for students pursuing higher education.

"Having been on the board since 2017, my passion has grown exponentially as I've seen the impact that we have for these students," Hamil says. "As we all know, the cost of higher education is skyrocketing, and these kids deserve the opportunity to chase their dream, whether that be through a trade program, a two-year degree or anything beyond. We want to help them reduce as many barriers as we can. They have the potential to change the world, and being just a small part of that brings me so much joy."

Becky Bonefas, a board member, echoes Hamil's sentiments, noting the invaluable role volunteers play in making the foundation's mission a reality.

"It's rewarding to be a part of such a committed group of people working together supporting the education goals of our district's students," she says. "Obviously, we couldn't make the annual scholarship awards happen without generous financial support, most notably through the RED dinner. But we also couldn't make it happen without the volunteer hours put in by all of our board and committee members."

Bonefas, who works for an area college, has also seen the impact of the DCG Education Foundation in her everyday life.

"A few times a semester, I will have a DCG graduate come into my office, and I always ask, 'Did you receive a scholarship from the education foundation?" she shares. "It's a source of pride for both the students and myself to see the smiles when they answer, 'Yes, I did,' and get to really see the work of the foundation in action."

For many board members, like both Bonefas and Mary Tjeerdsma, helping seniors pursue their dreams is personal.

"The reason I got involved was to help graduating seniors have an opportunity to further their education either at a traditional or non-traditional institution," Tjeerdsma says. "There have been a number of scholarship recipients who have stated these scholarships help them focus on their studies, fine arts or athletics and not stress about the financial burden."

Tickets for the RED Dinner are \$75 per person or \$500 for a table of eight. More information and tickets are available at the DCG Education Foundation website, www.dcgeducationfoundation.org. ■

THEY ELIMINATED the stretch and other reasons to revisit your legacy plan

Recent law changes, including changes to IRAs, gift tax laws and trust rules, may have made legacy plans outdated.

You used to be able to leave your IRA to your children or grandchildren to use when they needed



to help their children, grandchildren and greatgrandchildren pay for college tuition or purchase their first home. Recent legislation eliminated your ability to "stretch" IRA distributions across multiple generations (your children's or grandchildren's lifetimes).

Now, your family is forced to liquidate (and pay taxes on) your IRA much sooner, even though sudden extra income could impact their taxes. This massive change, included in the 2019 SECURE Act, killed the stretch and put in place the 10-year rule, meaning, generally, that if you leave your IRA to someone other than your

spouse, they have to withdraw (and pay taxes on) the full value of an inherited IRA or 401(k) within 10 years of inheritance.

Pass-through or conduit trusts were common ways to protect assets while allowing heirs to enjoy the benefits of an inherited IRA. However, recent laws removed many benefits of making trusts beneficiaries of IRAs.

Current laws have nearly doubled the estate and gift tax exemption through the end of 2025 (it's \$13.61 million per person or \$27.22 million per couple in 2024). Plans may include formulas based on old federal estate-tax exemption amounts, which were as low as \$675,000 in 2001.

Many Tax Cuts and Jobs Act provisions are set to expire at the end of 2025. However, for some, there are actions they may want before then regarding gifts and the type of assets that are best for gifting.

It can be challenging to keep up with the changes and understand how they impact you, but working with someone who does is essential. After the SECURE Act passed, we contacted several families and individuals we serve to discuss their IRAs, the end of the stretch and other options, including an IRA relocation strategy for helping them achieve their legacy ambitions.

Sometimes, people think legacy planning strategies are only for the super wealthy, but minor changes to retirement savings of all sizes can significantly impact how much you can leave to your loved ones and charities.

There are some strategies that you may want to take advantage of now before the rules change again. You might be surprised to see how much more you can leave to your loved ones and save on taxes just by making a few small changes to your legacy plan.

QUILTS of Valor honor service members

A warm embrace for veterans

The Quilts of Valor Foundation is a nationwide organization that honors veterans with handmade quilts as symbols of comfort and appreciation for their service.

Inspired by a mother who crafted a quilt for her son serving in Iraq, this movement has grown into a well-organized effort that touches the lives of veterans across the United States, including those in the Dallas Center and Grimes communities.

The process begins when a veteran is nominated, often through their local American Legion chapter

or by family members, to receive a quilt. Once a nomination is submitted, the Quilts of Valor Foundation evaluates and selects recipients, and the quilt is custom-made to reflect each veteran's service. The quilt is not only a token of comfort but also a deeply personal acknowledgment of a veteran's sacrifice, with the veteran's name, rank and service details sewn into it.

This past summer, the American Legion Post 49 in Dallas Center and its Auxiliary presented Quilts of Valor to 10 veterans in the area. At a ceremony to present the quilts, roughly 60 family members and friends of the veterans attended.

During the event, the quilt is draped around the veteran's shoulders. One recipient, Larry Murray, was so proud of his quilt that he wore it throughout the ceremony, despite the warmth of the summer day.

Mike "Buck" Buckalew, commander of American Legion Post 49, shares another experience that highlights how meaningful these Quilts of Valor are to recipients. Last spring, veteran Jerry Zayman received one. He served in Vietnam during the height of the war and received several medals but told Buckalew, "The quilt is something special to me. You can look at medals, but the quilt is something you can put on that's a comforting feeling."

For Wilma York, president of the American Legion Post 49 Auxiliary and a key figure in the Quilts of Valor process, the joy comes from witnessing how much these quilts mean to both veterans and their families.

During each ceremony, family members are invited to share in the presentation, whether at formal gatherings or in more intimate settings like the case of one veteran, who received his quilt at home due to hospitalization.

"It's very special for the family," York says.

The Quilts of Valor serve as reminders that the nation remembers and honors the sacrifices of its veterans. This is a key reason why receiving a quilt can be such an emotional experience.

York recalls a powerful moment when they presented a quilt to a veteran taken to a nursing home in Ankeny.

"When we left, he said to his daughter, 'Now you take that home because, if I keep it, here, it might get dirty,' "York says. "She thought he needed to have it, so she got him a quilt hanger and put it on his wall. He was very emotional by it."

The Quilts of Valor Foundation not only provides comfort through these quilts but also creates connections among veterans, their families and the community, ensuring that the sacrifices of those who served are never forgotten.



Perfect place to downsize

Eighteen years ago, Shellie Flockhart arrived in Dallas Center and was captivated by its charm.

She found the perfect house to make her home but says what truly made her fall in love with the community was the Easter egg hunt she attended after she moved in.

"We joined the town in an Easter egg hunt, reminiscent of the movie 'Steel Magnolias,' filling the air with joy and laughter," she says.





CIVICS IQ test

Civics? It is the study of the rights, duties and responsibilities of citizenship. We all are quite aware that we have rights. However, are we aware that we have duties and responsibilities? A civic duty is a legal obligation that is required by law. Failure to fulfill these duties typically results in legal consequences, such as a ticket for speeding. A civic responsibility is a social obligation that is perceived as important for the benefit of the community and society, but it is not legally required. These responsibilities are based on ethics and morality rather than law, such as

• Are the Democratic and Republican parties part of a branch of the government, and if so, which?

Answer 1) The governor serves under the executive branch of the government. This branch enforces the laws that are passed by the legislative branch and is responsible for all the administrative agencies that make rules about how to enforce the laws (departments of transportation, revenue, health and human services, corrections, education, agriculture, etc.). The governor appoints the heads of these agencies, and they answer to the governor. We refer to this as a "political appointment." Frequently, the person appointed to the top job is of the same political party as the governor. When the governor changes, typically, so do the heads of these agencies.

Answer 2) Both. In a democracy, each vote counts equally. Majority wins. Local elections are by democratic vote. In a republic, one person is chosen to represent the wishes of many. A state representative is chosen by democratic vote; however, the president is chosen by representative vote (electoral college). Individual laws are passed by representative vote rather than democratic vote. Therefore, our system of government is both a democracy and a republic.

Answer 3) A city council votes on ordinances that are enforceable for that city, which is a republic form of process.

Answer 4) Political parties are not part of the government. They are private organizations that devise their own methods of how to decide who will represent the party in an election for a government role. Republican Party does not equate to republic. Democratic Pary does not equate to democracy. They are just titles, not descriptors.

- Fill large pot with water. Bring water to gentle boil over medium-high heat.
- In medium bowl, stir ricotta cheese, Parmesan cheese, thyme, orange zest and pepper.

- Place four wrappers flour sides down on cutting board. Spoon 1 1/2 tablespoons cheese mixture onto center of each wrapper. Using back of spoon, press down on cheese mixture to create well about 1 1/2 inches across (width of large egg yolk), leaving at least 1/2 inch space around edges of wrapper. Without breaking it, carefully place one egg yolk in center of each well.
- Using pastry brush, brush edges of wrappers with egg white. Place one top wrapper with flour side up on each bottom wrapper. Using thumbs and forefingers, firmly press edges together to tightly seal each ravioli. Set aside.
- Using slotted spoon or spatula, carefully drop each ravioli into boiling water. Cook 2 1/2-3 minutes, or until wrappers are al dente (cooked not too soft but not overdone).
 Using slotted spoon, gently remove raviolis from pot, draining well. Transfer to plates.
 Drizzle with oil. Sprinkle with almonds, sage and bell pepper, if desired.
- Tips: Gyoza wrappers (or shumai wrappers) are preferred because they're thinner than wonton wraps. Look for gyoza wrappers in the dairy aisle, deli department or freezer



section.

Use these guidelines to determine how you want eggs cooked: At 2 1/2 minutes, eggs are yellow and slightly thickened but not set around edges, similar to sunny-side up. At 3 minutes, eggs are deeper orange and slightly set around edges, similar to over-easy. ■

• Take care of your health. Grief can take a toll on your body, so be sure to eat, drink water and sleep. It might feel hard to keep up with these things, but they're key to healing.

• Don't set a timeline. Grief comes and goes. Healing takes time. Give yourself permission to heal at your own pace.

Working through the grieving process might feel like a roller coaster at times. Even years after a loss, you may be triggered by certain events, places, or smells that remind you of what you once had.

PRESIDENTIAL elections and market performance

all too familiar with, and Sciona will need his help to finally understand where her real power lies. Together, these two will start the kind of revolution that will change the world.



A LOT can change in 50 years

History has a way of revealing what truly matters. Every day, we're bombarded with news of global events — conflicts, elections, major sports and celebrity happenings. Consider a moment from nearly 50 years ago. In January 1975, Popular Electronics magazine featured the Altair 8800 on its cover, introducing the first commercially available personal computer. 


