More than costumes

For many years, Brenda Hummel-Foreman has made her daughter, Andrea Capaldo's, Halloween costumes for one simple reason: Andrea is a wheelchair user, and there just aren't many options available.

For Andrea's first three Halloweens, Hummel-Foreman bought store costumes like candy corn, a bunny and a zebra. They were easy to get on because Andrea was still small.

"However, I felt we needed to do something bigger, something extra because she deserves it, and the wheelchair somewhat hid what she was wearing," Hummel-Foreman explains.

So, in 2012, she dreamed up a frog on a lily pad costume in memory of her own mother, who had passed away two years earlier.

"I went so big on this one, and I didn't think about access into the building or in the van," she recalls with a laugh. "The lily pad/ water was too wide, so we had to take that off just to get inside. It was pretty funny, but she was a big hit, and, from there, it became a challenge for me to go bigger and better and continue to make it fun and interactive for Andrea."

That year sparked a tradition — and a following. Each Halloween, people began asking what Andrea would be. Hummel-Foreman always kept it a surprise until the big reveal.

Over the years, Andrea has been everything from Velma in the Mystery Machine to a gumball machine, a butterfly, a tissue box and a crayon box. One of Hummel-Foreman's most memorable projects was dressing Andrea as Ellie from the Pixar movie "Up," while her brother, Sal, played Carl.

"The best memories are any time I can get the whole family on board with my crazy ideas," she says.

When designing, Hummel-Foreman starts with Andrea's personality, then searches for ideas online and imagines how to adapt them to her daughter's wheelchair. Andrea's tray and canopy poles offer easy ways to attach cardboard or build around the chair, and sometimes the whole family gets in on the fun.

"They know they are supporting Andrea, and it reflects unity and that we are all in this together," she says. "It's making memories, being silly and having fun. It takes our mind off the stressful times related to Andrea's complex medical needs and helps us see how far she's come."

Hummel-Foreman has noticed some positive changes in adaptive costumes in recent years, with stores like Target leading the way.

"They still look like costumes but might include special tube access for kids who are G-tube fed like my daughter, or roomier legs for easier dressing," she explains. "They also have cardboard or felt pieces that can be added to the side of the chair or wheels. But the best and most creative adaptive Halloween costumes still come from the parents who customize around their child's needs."

For Hummel-Foreman, the effort is worth every hour spent.

"As a mother of a child with complex medical needs, I'm exhausted mentally and physically, and sometimes there are more bad days than good. But anytime I can be a little extra with my daughter and let her shine, that's where I start."

Her advice for other parents? Begin with your child's personality and comfort.

"Start with what they like and enjoy, then think about how to make it happen," she says. "If a costume is easy to put on, start there and build around it with accessories. If it's too difficult or uncomfortable, work from the outside in and create something grand. Sometimes accessories are all you need to bring a costume together."

Cardboard has been her best tool. It's lightweight, cheap and easy to cut, tape and decorate. And, no matter how elaborate the final product, the result is always the same: Andrea gets to shine.

"I just want others to see my daughter having fun and doing activities her peers do, not her disabilities," Hummel-Foreman says.

Going all out

Jessica Bormann and her husband, Keith, went to college at Iowa State University — the place their love for going all out for Halloween started.

"Campus life brings out fun and unique theme parties, and we never missed a chance to dress up and dive into the fun," Bormann says. "When Halloween week rolled around, Welch Avenue turned into a full-blown Halloween costume party. The bars were buzzing with creativity, and it was so much fun seeing everyone's outfits."

Since then, the Bormanns have made a point to go all out every year when Halloween rolls around.

Her top five favorite costumes over the years have been the ones that

have also been crowd pleasers.

First, there were the trophies. Six friends went full gold, painted head to toe, and became trophies for the night.

Then came the square dancers — a costume that was a blast from start to finish.

"The hunt for the perfect outfits was half the fun," Bormann says. "We scored our gear on eBay, complete with authentic square dance flair thanks to the Grandins. The best part about this costume was the group we went with. We even rehearsed a group do-si-do with a real caller and performed it throughout the night. It was a hilarious, unforgettable night."

Next was "Dumb & Dumber," something Bormann says was "easy, comfy and instantly recognizable."

"The real challenge was finding a moped," she says. "We ended up with a retro e-bike that worked perfectly — and yes, we rode it around Polk City and even in a few bars. People were shouting quotes at us all night. 'So, you're telling me there's a chance?' "

And who could forget Harry and Marv from "Home Alone"?

"Keith nailed his costume dressed as Marv, and we went all in on the details: gold tooth, iron burn, doorknob 'M' hand mark, you name it," Bormann says. "Everyone knew exactly who we were, and it was a total

hit during the pub crawl."

Finally, Bormann has fond memories of the Zombie Wedding Party.

"This one was a full production," she shares. "We had a real bride in a wedding dress, five bridesmaids in matching royal blue and groomsmen in tuxes with blue bowties. We even brought props and did a bouquet toss at the party."

When it comes to creating these costumes, Bormann says one of the hardest parts is tracking down props, like that year she needed multiple royal blue bridesmaid dresses.

"That was a full-on treasure hunt," she says. "But honestly, that's part of the fun. I love digging for quirky accessories and unexpected extras that take a costume to the next level."

Like when Bormann and friends did "Office Space," they made sure to have a minimum of 15 pieces of flair and carried a red stapler and TPS reports. Or the year they went as Roller Derby Girls.

"A few of us wore actual roller skates and spent the night skating around the Legion," Bormann says. "It's those little touches that make the night extra fun and totally worth the effort."

Halloween doesn't just stop at costumes and parties for Bormann, though.

"The kids and I always have fun decorating the yard for Halloween, and we try to make the house extra spooky for trick or treat," she says. "And while our kids have outgrown trick or treat night, we still love walking around Pine Ridge on Beggars Night, and our neighbors turn their garage into a haunted house every year."

Because of all the fun memories she's made over the years, Bormann has one big plug: participate in Polk City's Halloween Pub Crawl.

"Whether you wear a pumpkin T-shirt or a costume, it's such an entertaining night out," she says. ■

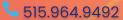

A SAFE place to heal

Community shows up for Officer Cade Moritz





When the call went out for a need to finish the basement of injured police officer Cade Moritz, businesses and individuals stepped forward to do the work and buy the supplies.

Last September, news broke that Cade Moritz, a police officer with the Des Moines Police Department, had been shot during an exchange of gunfire with a suspect. He survived.

Later that month, he was discharged from the hospital and escorted by fellow DMPD officers to a rehabilitation program, where he continued his recovery.

Bry Wisecup, an area Realtor, heard the news soon after it happened. Moritz and his fiancée are her clients, as well as friends of hers and her husband's.

"When we learned of the shooting, it was actually my husband's idea to jump in and help by finishing the basement so Cade would have a cool, dark place to recover from brain surgery," Wisecup explains. "He knew, because of my career, I'd have the connections and community to make something really cool happen."

Prior to the shooting, Moritz and his father had just started working on his basement. They had only begun the framing when the incident occurred.

"We really had to line up contractors for every step of the finishing process," Wisecup explains. "Everything from framing to drywall hanging and texturing, plumbing, HVAC, electric, painting, trim work, cabinets, etc."

Ultimately, many contractors and donors came through, including 10G Heating Cooling Plumbing, C&K Electric, AD Premier Plumbing and more.

"Nathan Gillmore of 10G Heating, Cooling, and Plumbing in Elkhart was my most local contractor, and he was the biggest help," Wisecup says. "He assisted in coordination of the permit work with the city, and the city even waived their fees for the cause."

Wisecup says her commitment to the project stems in part from her deep respect for law enforcement.

"They put their lives on the line every day, and this was a very real reminder of that," Wisecup says. "Coordinating vendors to give Officer Moritz a safe place to recover was the least I could do."

She also hopes the effort shows the power of community when someone is in need.

"'Iowa Nice' is a very real thing," she says. "When you ask for help, Iowa shows up. The contractors who put their paid work on hold so they could donate their time to help finish this project in a timely manner are so appreciated. All of the donors who sent money to help us pay for supplies do not go unnoticed either. Finishing a basement is not cheap, and I am so amazed at how the community showed up for Officer Moritz." ■

IMPORTANCE of having an advance directive

Everyone should have an advance directive in place which expresses your wishes regarding medical care and nominates a person to make those decisions for you.



Competent adults
have the right to refuse or accept medical
treatment after being informed of the
procedures and risks. However, there is concern
over how these medical decisions will be
made when a person is unable to make these
decisions. An advance directive states your
health care choices in writing while you are
still able to articulate your decision.

If you have not executed an advance directive and are unable to make decisions, others will make health care decisions for you. Difficult and emotional decisions may fall to your spouse, children, or parents. If

your family disagrees on a course of action, problems can arise.

An advance directive expresses your health care choices in writing and nominates someone to carry them out. Without one, you have no control over who makes the decision or the choices made.

Two advance directives are crucial. A Durable Health Care Power of Attorney is a document through which you name another person to make health care decisions for you if you are unable to make them. Your agent is required to follow the directions you provide. If your wishes aren't known, your agent will make decisions in your best interest based on discussions you have had with your agent. The document is "durable" because it remains effective even if you become incapacitated or incompetent.

A Living Will is a written document that expresses your directions for your medical care if you are unable to express your wishes yourself. It can direct your physician to withhold or withdraw certain life-sustaining procedures if you are in a terminal condition. However, it can be much more comprehensive, including what you want to happen in various situations.

These two documents work together. The health care power of attorney nominates somebody to make medical decisions for you. The living will gives your agent directions on specific decisions.

Advance directives allow you to anticipate medical emergencies and participate in your future care. These documents make health care decisions in advance and create peace of mind for you and your family. The most effective estate planning is accomplished before you need it.

TRICKS, treats and pet safety this Halloween

October has always been one of my favorite months (and not just because it's my birthday month). There's something about the changing leaves, crisp fall air, and picking out pumpkins that calls to me. But my favorite part of October? Halloween!



And I know I'm not alone. "Spooky season" is a favorite for many, with costumes, scary movies and the joy and community of trick-ortreating. Our pets, however, may not share the same enthusiasm. For them, Halloween can be stressful and even risky in ways we don't always think about. Here are some things to keep in mind to make the holiday safer for our furry (and feathered) friends:

Candy: A full bag of candy is every child's dream — but a pet's nightmare. Chocolate, raisins and sugar-free gum or candy are toxic, and xylitol (common in sugar-free products)

can cause life-threatening hypoglycemia and liver failure. Even "safe" candies can upset stomachs, and swallowed wrappers may cause blockages. Keep candy bowls out of reach and remind kids that sharing sweets with pets is never a good idea.

Costumes: Pet costume photos are adorable, but not every pet enjoys dressing up. Choose outfits that are comfortable, don't restrict movement, and leave the face uncovered. Start a week or two in advance with treats and praise. And always supervise because, while a cape makes a dog look like a superhero, it's not so super if it gets chewed or tangled.

The front door: A parade of trick-ortreaters can overwhelm even calm pets. Dogs may bark, rush the door or try to slip outside, and cats can dart out unnoticed. Consider a baby gate for dogs and a quiet, secure room for cats. Pheromone diffusers can help, and your veterinarian can advise if a short-acting antianxiety medication is appropriate.

Decorations: Cobwebs, cords, glow sticks and candles may look festive, but curious pets see toys... or snacks. Swap open flames for battery-powered candles and keep décor out of reach. Batteries themselves are especially dangerous if chewed or swallowed.

With a little planning, Halloween can be fun for the whole family — without a late-night trip to the vet. The best treat for your pet is a safe, cozy evening with you.

One last reminder: Don't stop heartworm, flea and tick prevention for fall and winter. Fleas and mosquitoes can survive and reproduce indoors, and ticks become active when temperatures rise above freezing, even with snow on the ground. To keep your pets fully protected, these products should be given monthly, year-round. ■

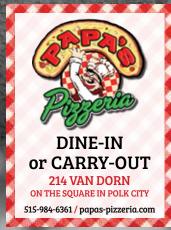

CREAMY tomato soup is rich with sun-ripened flavor

There is something special about cooking with ingredients grown from your own backyard. Recently, I was watching our grandson at my daughter and son-in-law's house. He and I ventured outside to check on their garden and discovered a bumper crop of tomatoes.



Since the weather was cool, I decided that a batch of tomato soup for dinner would serve the harvest well. Our grandson, just 8 months old, is already a curious observer in the kitchen. He keeps me company from his high chair, happily armed with a dozen measuring cups to toss and a few snacks to keep him content. This creamy tomato soup, made with an abundance of fresh-picked tomatoes and a blend of herbs, is rich with sun-ripened flavor. Paired with a golden, melty grilled cheese on homemade sourdough, it was the perfect fall dinner - simple, cozy and made even sweeter by sharing it together with my grandson. ■

Creamy tomato soup

Total time: 45 minutes Servings: 4

Ingredients:

- 1 medium onion, chopped
- 3-4 garlic cloves, minced
- 2 tablespoons olive or avocado oil
- 2 pounds fresh tomatoes (about 6 large), blanched, skins off and chopped
- 2 cups chicken broth (low sodium preferred)
- 1/3 cup Parmesan cheese, grated
- 1/2 -3/4 cup heavy (whipping) cream
- 2 tablespoons honey
- Salt and pepper, basil, oregano more of everything than you think
- Pinch of rosemary
- · Fresh basil or parsley (optional, for garnish)

Directions

- · Heat oil over medium heat. Add onion and sauté for about 5 minutes until soft.
- Add garlic and cook all for 2 more minutes.
- Add tomatoes and cook for 10 minutes.



- · Add chicken broth and bring to a boil. Reduce heat and simmer for 20 minutes, uncovered. Stir occasionally.
- Blend until smooth by using an immersion blender and scooping the mixture into a traditional blender. Return soup to the pan.
- Add whipping cream and honey and stir. Season with salt, pepper, basil, oregano and other herbs of choice.
- Simmer for 5 more minutes.
- Serve immediately. Garnish with fresh basil or parsley. This pairs well with a grilled cheese sandwich on sourdough bread. Enjoy!

MEET Anne Sloan

Sloan makes move to school counselor.

Anne Sloan has nearly two decades of experience working in education.

Originally from Decorah, she attended Iowa State University for her undergraduate degree. After college, she moved to Minnesota, where she landed her first teaching job at Holy Family Catholic High School in Victoria. Over her 10 years there, she and her husband started their family. Before their oldest was ready to begin school, they faced a big decision: stay in Minnesota or move back to Iowa.

"We missed Iowa and our friends and family," Sloan shares. So, the deal was sealed.

Her husband was the first to find a job, and, soon after, Sloan learned of an opening in the North Polk Community School District. She already knew people in the district and, as luck would have it, a PE/health teaching position became available right as their family decided to return.

"I had heard wonderful things about the school district, and we knew we wanted a somewhat smaller district in which there was a good community vibe, and North Polk has been that place for sure," she says.

This year marks Sloan's ninth in the district. For eight years, she served as the high school PE/health teacher, but this year she has stepped into a new role as middle school counselor while pursuing a master's degree in school counseling at Drake University. Her goal is to help others understand that everyone's journey in life is different — and that experiences don't always determine a set path.

"I really have found my passion in the area of mental, emotional health and wellness, and I really wanted to work with students beyond just the classroom," Sloan says. "I want to dig deeper into supporting our youth and our communities by being able to meet with them in a one-on-one or group setting where I have more time and opportunity to help and support them."

With a background in trauma-informed yoga, Sloan has enjoyed incorporating those skills into her teaching and plans to continue doing so as a counselor.

Though she is still settling into her new role, Sloan appreciates the opportunity to interact with students in new ways.

"I think a passion and area that I still get to be part of is forming those positive relationships with students," she says. "I think this is such an important piece of being in education and being a school counselor.

"Every person has — and comes from — a variety of different experiences, and it is so important to meet them where they are at and 'walk with them' in supporting them to help ensure they have what they need to find success and happiness in their lives, which also looks different for everyone," she adds. "Life is not a 'one size fits all' approach."

Outside of work, Sloan enjoys staying active and spending as much time as possible with family and friends, especially with her three daughters: Avery, 12; Raegyn, 10; and Taylor, 9.

"We are on the go but truly embrace the moments where we can just relax at home and grill and embrace the fall weather," Sloan says. "I have to remind myself to slow down and breathe and take in the moments intentionally." ■

PREVENTING and recovering from identity theft

No one can escape the potential of becoming a victim of identity theft. It can happen to anyone, at

In 2024, the Federal Trade Commission (FTC) received more than 1.1 million identity theft reports and nearly 2.6 million cases related to fraud, collectively costing more than \$2.7 billion. The most common theft was credit card, and the most common type was imposter scams.



While there is no guarantee to keep you safe, there are many preventative measures you can take to reduce risk and protect your personal information.

Secure your information: The most important step in preventing identity theft is to secure your personal information, whether that is online, on paper or stored within a personal device, such as a computer or phone.

The following are ways you can protect yourself:

- Do not carry sensitive materials, such as your Social Security card, Medicaid card, or other identifying information, unless necessary.
- Keep all documents with personal information stored in a safe location. This could be a fireproof safe at home. Ensure that, at work, you do not leave personal information accessible to others. Consider using a locking file cabinet for purses and wallets or keep them with you at all times.
- Never share personal information, including financial or health, with anyone else in any manner (online, phone or written) unless you initiated and trust the other person.
- Do not use a debit card for purchases. Select one credit card and use it to pay off each month.
- Do not use the same passwords for all your secure logins. Each should be strong and different from the others.
- Monitor your bank accounts daily and review statements for any discrepancies.
 - Monitor your credit reports.
- If you are donating or throwing away any technology, make sure you have wiped the data clean of any personal information that may be stored on

Preventing identity theft is crucial to avoiding the serious consequences of identity theft; however, what if it has already occurred? How does someone recover from identity theft? Let's take a look.

If you've been a victim or suspect identity fraud, follow these steps: Call credit companies, banks, and other companies where fraud may have occurred and alert them of the fraud, and freeze or close accounts. Change all the passwords and PINs for your accounts. Place a fraud alert with one of the credit bureaus (Experian, TransUnion, or Equifax). Report the fraud to the Federal Trade Commission (FTC). Report the fraud to your local law enforcement.

Once you have completed the above, it's time to recover and repair damage by doing the following: Close any new accounts that were opened in your name. Remove fraudulent charges from your accounts by contacting those businesses. Work with the credit bureaus to correct your credit report. Review your credit reports often.

Taking precautionary steps to secure your personal information is the first step to protecting yourself from identity theft. In addition to the above tips, your financial institution can also support you in ensuring your finances are safe and can offer additional security measures.

LEGACY is more than a will

What we leave behind through who we are.

We tend to think of legacy as something we leave behind when we're gone — the material possessions that supposedly carry on our will — things such as a house, a savings account or a well-written will. Those things matter,



but most people won't be remembered for their possessions. They will be remembered for the way they lived.

All of us, to some extent, are building up our legacy, whether we realize it or not. It shows up in how we respond to hardship, how we treat people who cannot repay us, and in the words we choose when no one else is listening. Legacy is not built in one big moment. It is built quietly, over time.

Some people are remembered for what they built or accomplished. However, people are

remembered more for the ones who leave the deepest mark through their kindness, their consistency, and their quiet example. That kind of legacy carries on. It shows up in the way your kids treat others, in the stories your grandkids tell, or in the way someone else makes a decision because of something you once said or did.

I've talked with many older adults who wonder whether their life has made a difference. They may no longer be working or providing for a family in the way they once did, but I see something else. I see the steady hands that carried others through loss. I see the quiet strength that held a family together. I see the small, everyday faithfulness that few ever noticed but that mattered more than they know. Even if your story feels unfinished or marked by regret, legacy is still a choice you can make. It does not depend on a perfect past. It starts now with how you show up, how you speak, how you forgive. Even a simple offer of reconciliation unreciprocated can become part of the story you

leave behind.

You do not have to be wealthy or well-known to leave something meaningful behind. You simply have to be intentional. A legacy can be as simple as offering encouragement when it is needed most, forgiving when it is hard, or showing up for someone when no one else does.

As we move into a season of family, gratitude and reflection, this is a good time to ask not "What am I passing on?" but rather, "What will people remember about who I was?" We were not created just to build something for ourselves. We were made to shape the lives around us. And, sometimes, the most lasting thing we leave behind is not what we gave, but how we loved those around us.

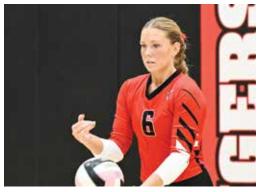
