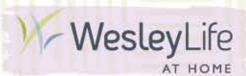

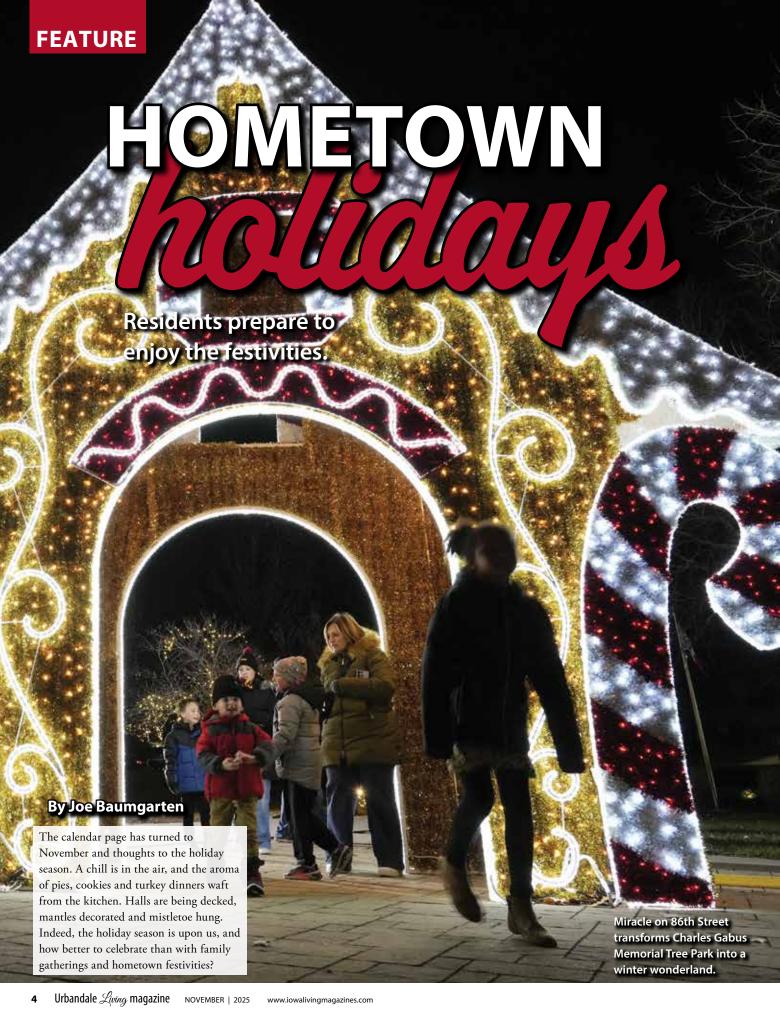

#### Miracle on 86th Street

Each winter, a corner of Urbandale comes alive with lights, laughter and community joy. As the chill settles over Iowa, the town brightens with twinkling lights, laughter and community spirit. It's called the Miracle on 86th Street, and, for four years now, it's been transforming Charles Gabus Memorial Tree Park into a winter wonderland where families gather, neighbors reconnect and holiday memories are

What began as a simple idea to "get people outside in the winter," as Parks and Recreation Assistant Director Scott Hock explains, has grown into a beloved local tradition.

"We were just looking for something to do — something that would bring people together," he says. "Council supported it right away, and, every year since, it's just gotten bigger."

At the heart of the event is the Mayor's Tree Lighting, when the mayor flips the giant switch to illuminate more than 100,000 sparkling lights throughout the park. From that moment on, the entire space glows: trees wrapped in color, joyful displays shining against the night

sky, and children running from one dazzling feature to the next.

Over the years, the display has grown with creative new "centerpieces" each season.

"The first year, our crew made a wooden train we call the Jolly Holly Trolley," Hock says. "Then came a giant gingerbread house, last year the light-up JOY letters, and this year's new feature is a walk-through ornament."

Each piece is designed not only to light up at night but to look beautiful in daylight, too.

"We wanted it to be something families could enjoy all day long, not just after dark," he says.

Families have quickly embraced the tradition. Many come year after year to snap photos in the iconic holiday sleigh, lovingly built by a city crew member and glowing with festive lights.

"The goal," Hock says, "is that people can take those pictures when their kids are little - and then come back years later with their

grandkids to do it again."

The Miracle on 86th Street isn't just about the lights, though. Throughout the season, visitors can enjoy special activities like visits from Santa, a candy cane hunt, and a family scavenger hunt. There is even an ice rink nearby for those who want to lace up their skates and make a full day of winter fun.

Unlike the drive-thru light shows found elsewhere, this one encourages everyone to bundle up and enjoy a stroll.

"We're from Iowa," Hock laughs. "We're supposed to embrace the cold weather. You can

see it from the road, but you can't experience it unless you get out of the car."

With its location near the library and police station, the display stays lively and safe — and, over the years, it has become the backdrop for countless family moments.

"We've had one marriage proposal that we

know of," Hock says. "It's just that kind of place."

This year's lighting ceremony will take place on Nov. 25 at 5:30 p.m., timed perfectly with sunset for that magical glow. The lights will shine through early January, giving everyone plenty of chances to visit, stroll and soak in the spirit of the season.

Whether you come for the photo ops, the nostalgia, or simply to feel that hometown holiday cheer, Miracle on 86th Street is proof that a little light — and a lot of community can make even the coldest nights warm.

#### Santa's Rockin' Lights

Every holiday season, Living History Farms in Urbandale transforms into a mile-long tunnel of twinkling color, rhythm and joy. It's called Santa's Rockin' Lights, and, for seven years, it's been dazzling families with a drive-thru experience unlike anything else in central Iowa.

"This isn't just a light show — it's a tradition," says Peter Starykowicz, the event's organizer. "We want this to be something families do every year, something they come back to with their kids, and someday their kids

bring their kids."

That spirit of continuity runs through every flicker of light. Since its debut in 2019, Santa's Rockin' Lights has grown into one of the region's premier holiday attractions. Each year brings new displays, new music and new reasons to roll down the windows (or pop open the sunroof) and take in the glow.

What makes Santa's Rockin' Lights different? In a word: synchronization.

Every arch, tree, snowflake and Santa display is programmed to move and flash precisely in time with the music.

"If the beat goes bup-bup-bup, the lights go bup-bup-bup right along with it," Starykowicz explains. Behind the scenes, more than 50 computerized control boxes and miles of Cat6 network cable bring hundreds of thousands of LED lights to life, creating a mesmerizing, mile-long show of motion and sound.

"It's not just plug-and-play," he says. "It's hundreds of hours of programming. Every blink, every fade, every shimmer is choreographed. It's a labor of love."

The result is a show that feels alive — like the lights themselves are dancing along with your favorite holiday songs.

Each season brings something new, but this year's centerpiece is a showstopper: a 120-footlong animated train dubbed The Santa Express.

"It's massive. Fifteen feet high and the length of a city block," Starykowicz says. "Each car is animated and synchronized to music. You'll see Santa waving from the locomotive, reindeer prancing in rhythm, and even a Santa rock band jamming along."

The train's playful energy fits perfectly with the event's theme: holiday magic with a rockand-roll twist. While it may conjure thoughts of The Polar Express, Starykowicz says it is its

own creation.

"We love the connection people make, but this is our own Santa Express. It's a tribute to that sense of wonder trains bring to the holidays.'

While Urbandale's "Miracle on 86th Street" is a outdoor immersive exhibit, Santa's Rockin' Lights lets guests experience the magic from the comfort of their car.

"That's the beauty of it," Starykowicz says. "You can come in your pajamas, bring hot cocoa, stay warm and cozy, and still feel totally immersed in the lights."

Visitors drive slowly — about 3 miles per hour — along the mile-long route, which takes about 20-25 minutes to complete. Along the way, you'll encounter towering snowflakes, glittering tunnels, playful reindeer, and yes, plenty of rockin' Santas.

There's even a 20-foot-tall 3D Mr. and Mrs. Claus, polar bears and — for a touch of whimsy - giant illuminated dinosaurs, which have become a crowd favorite.

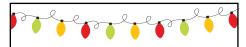
"It's definitely family-friendly," Starykowicz says.

Hosting the event at Living History Farms adds another layer of charm. The historic setting, nestled among wide-open fields, allows the lights to shine against a dark, peaceful backdrop.

"It's not like driving through a city," Starykowicz notes. "You're surrounded by open space, so you can really focus on the experience."

The partnership with Living History Farms feels fitting.

"They're a venue of tradition," Starykowicz adds. "They're constantly improving, but they always honor their roots. That's exactly what we're trying to do — build something that lasts."

"We want to be around for 25 years and beyond," he says. "We're building memories that families will look forward to every holiday season."

That vision — of lights, laughter and community spirit — has made Santa's Rockin' Lights more than just a drive-thru show. It's a place where Urbandale families can reconnect with the joy and wonder of the season, year after year.

So grab your loved ones, load up the car, and roll through a mile of dancing lights. You might just start a new tradition.

### **ABLE** account changes help those with a disability

There are exciting new changes to the Iowa ABLE account program that help individuals with a disability make self-directed investments and purchases.



The Achieving a Better Life Experience

Act (ABLE) is a way to save money for expenses related to a disability. It is similar to (and is part of the federal statute for) 529 college-savings plans. An ABLE account allows individuals with disabilities to fund accounts with their own resources. Others, such as family members, can also contribute to the account. The minimum contribution limit to an ABLE account was recently reduced to \$1, effective immediately, making it easier for eligible individuals to start saving.

The account can be used to supplement, but not supplant, benefits received through

other government programs like Medicaid and SSI. Money from an ABLE account can be used to pay for education, transportation, health services, and employment-related expenses. Additionally, unlike some Medicaid trusts, funds from an ABLE account can be used for housing and basic living expenses. The beneficiary is allowed to have direct access to the money.

Other Medicaid trusts, such as a Special Needs Trust, do not allow funds to pay for funeral or burial expenses after an individual dies. Money in an ABLE account can be used to pay for funeral and burial expenses.

Account owners and members of their support system now have the opportunity to transfer funds from a Medicaid SNT into an ABLE account. This allows more flexibility when it comes to how assets are used.

Another advantage of an ABLE account is that most Medicaid trusts contain mandatory provisions subjecting any money remaining

in an the account after death to Medicaid recapture by the State. In Iowa, the Department of Health and Human Services is not permitted to recover money in an ABLE account and remaining funds can pass to a named beneficiary.

Currently, to be eligible for an ABLE account, an individual must be disabled, and the disability occurred before the age of 26. However, recent changes to the law will raise the age limit to individuals found disabled up to 46 years old. The new law goes into effect Jan. 1, 2026.

### URBANDALE COUNCIL RECAP



#### October 22, 2025 - Council Meeting

The City Council met on Wednesday, October 22, and began with a proclamation recognizing Filipino American History Month. Endow Urbandale also presented their grant recipients for 2025.

The City Council approved the first reading of a rezoning from Agricultural Reserve District (A-1) to Planned Unit Development (PUD) for Des Moines Christian School's new 102-acre campus near Meredith Drive and Aurora Avenue.

The land was recently severed from Grimes and annexed into Urbandale, clearing the way for development. The campus would

include academic and athletic facilities plus an early education center.

The PUD establishes clear rules for how the site will be built and used, including traffic upgrades (turn lanes, potential signals, sidewalks/trails), landscaped buffers, and a 60-foot building-height cap.

ZIP Codes: The Council also approved hiring Van Scoyoc Associates for \$1,000/month for 12 months as part of a multi-city lobbying coalition related to ZIP Code issues. New residents are regularly reporting mail delivery problems with USPS-assigned ZIP Codes.Van Scoyoc will assist Urbandale and other cities in advocating for federal bills H.R. 672 and H.R. 3095 requiring USPS to assign single, unique ZIP Codes to listed communities.

#### October 8, 2025 - Council Meeting

The Mayor and the City Council met on Tuesday, October 8, and began with a proclamation recognizing National Disability Employment Awareness Month. The Urbandale Water Utility is working on plans for an Aquifer Storage and Recovery (ASR) well in western Urbandale near the current 170th Street water tower—an infrastructure play to lock in safe, reliable drinking water for decades. ASR wells store treated water underground during low-demand months, then pulls it back when it's hot, dry. or demand spikes. The City Council approved a noise ordinance waiver for the project, setting the stage for the next steps which include designing the project (details like diameter, target aguifer, injection/recovery rates). Construction on the ASR well could likely begin in 2027. This ASR well is a long-horizon investmentquietly building a margin of safety into Urbandale's water system so households and businesses can count on clean, dependable water in dry spells, growth years, and everything in between.

This time of year can bring plenty of change, whether it is the leaves on the trees, the seasonal sports schedules, or the considerations for who brings the turkey and eggnog. With all the hustle and bustle of the upcoming holiday season, you may not be focusing on the required draw down of some of your life savings.



Individual Retirement Arrangements (IRAs) were created in 1974, and Required Minimum Distributions (RMDs) were required from the very beginning. RMDs are the minimum amounts that U.S. tax law requires

one to withdraw annually from traditional IRAs and employer-sponsored retirement plans. The purpose of RMD rules is to ensure that people do not accumulate retirement accounts, defer taxation, and leave these funds as an inheritance. RMDs force the holder to withdraw at least some of the funds as taxable distributions while they are still alive.

The rules apply to all employer-sponsored retirement plans, including profit-sharing plans, 401K, 403(b), and 457(b) plans. The RMD rules also apply to traditional IRAs and IRA-based plans such as SEPs, SARSEPs and SIMPLE IRAs.

The age to start taking RMDs has changed over time. The current age to begin taking RMDs is 73 as of 2023, according to the SECURE 2.0 Act, which was an increase from the previous age of 72. For those of us born after 1960, we need to consider RMDs at age 75. Individuals are generally required to start taking withdrawals from their retirement accounts by April 1 of the year following the year they reach the required age.

There are penalties for failing to take RMDs or not taking a large enough distribution. The penalty is an excise tax of 25% of the amount not distributed as required, or 10% if the RMD is corrected within two years.

To some people, this requirement will not be as great of an issue if you are already drawing retirement needs regularly from your pre-tax savings; to others, it may cause an increase in taxable income that was not expected or

This time of year, look at this future obligation. Maybe your required distribution is two to three years from now and you have room in your current tax bracket to explore other options. Many individuals consider ROTH IRA conversions to reduce the requirements at age 73. Others consider changing their annual tithing and donation expectations to have them come straight from the RMD qualified investments and go to the charities and churches of choice. Some may initiate a gifting effort to send this money in the direction of a loved one.

When it comes to retirement, you have worked hard the last 30-40 years. You have raised your family, given everything you can to save for your golden years, and now it is time for you to be able to live more like every day is a Saturday.

This time of year, let us be thankful. Let us take pause to thank those who have served to provide for the rights that we hold so dear. Let us embrace the spirit of family and friends. Don't forget to reach out to your financial advisor to get some of these end of year "requirements" in order so there are no surprises and you can walk into the New Year with a fresh start. # **MEET** Casey Clark

#### Carries on a passion for science

As an alumnus of the University of Northern Iowa, Casey Clark recalls that, during his formative collegiate years, he had a passion for science. Making the decision to pursue a career around the subject was simple.

"I enjoyed science, and I liked talking about science," he shares. "I felt that being a science educator would be the best way to keep doing that."

Clark says, when he graduated from college, he applied to most of the Des Moines metro schools. Urbandale High School was the first to offer him a job, and he has spent the last 12 years investing in Urbandale students through science.

"I attended Des Moines' Hoover High School, just a couple of miles from Urbandale, and Urbandale High School seemed like a nice place to go. I've taught everything except biology here, including physics and earth science. For the last few years, I've taught chemistry," Clark explains.

No teacher seems to pass his or her career without one challenge or another. For Clark, the biggest challenges take the form of student engagement.

"We (teachers) are competing with everything in the students' lives, so the challenge is to find ways to encourage high schoolers to engage in the curriculum," he says. "I enjoy creating a fun and challenging environment where students can learn."

For example, in his regular chemistry classes, Clark ties the understanding of chemistry to real life environmental challenges.

"It helps them see how the chemistry affects the world around us and explaining what we see is a tough ask of any high schooler."

Clark especially enjoys seeing students conquer a challenging concept. The students enjoy the victory, and he, in turn, relishes watching it happen in real time.

"Three years ago, I started teaching AP Chemistry," he shares. "On the first group's AP exam day, most of the students walked out of the exam feeling like they did a good job and were prepared well. That helped me feel like I succeeded in getting them prepared."

For individuals who aspire to become a science educator, or an educator in general, Clark offers some advice to aid in the journey: "You really need to enjoy the art of communicating with other people. It is good to understand your content, but it is important to understand the art of communicating it. It all comes down to relationships, and building positive student-to-teacher relationships makes all the difference. Those relationships are critical to success."

Since taking the teaching job in Urbandale, Clark has valued all the lessons and advice he has received from fellow teachers and colleagues.

"We've had several science teachers come and go over the years within our school," he says. "Each of them has impacted me in one way or another. We can learn a lot from our colleagues."

Clark says he looks forward to seeing where the new regular chemistry curriculum, which he says encourages student engagement, takes him and his students by the end of the year.

Nestled in the heart of Urbandale stands a house that's more than just wood and brick - it's a vessel of family stories, quiet secrets and community legacy. Sherrie McKennie, a lifelong Iowan with deep family roots in the area, recently sat down to share her memories of the Urbandale Historical Society Olmsted-Urban House, which once belonged to her great grandparents. Though she never lived there herself, the house played a starring role in her childhood.

"I used to visit for dinners and just to look around," McKennie recalls. "My grandmother would sneak me coffee with sugar and cream

when I was just 4. It was our little secret — I don't think my mother ever knew."

That mischievous ritual, shared between generations, paints a vivid picture of the warmth and closeness that defined McKennie's early years. "I had a great childhood," she recalls.

Mary Knueven is in the same PEO Chapter as McKennie.

"Sharrie is the daughter of Ruth Olmsted of the Olmsted family of Urbandale, Knueven savs.

Knueven and several other members of the local PEO Chapter thought it would be great if they could get McKennie to the house. It had

been many years since she had seen it, and many improvements had been made.

McKennie's great-grandparents, Leander and Charlotte Olmsted, built the house in 1904.

"I spent a lot of time here with my grandparents," she says. "My brother and I were the only grandchildren around, so we were always with them."

Her father, Clarence, was a refrigeration specialist — so skilled that even Omaha lacked someone with his expertise.

"They'd come get him to fix their refrigerators," Sherry says.

Her mother was a schoolteacher, and, in a twist of history, had to marry in secret because teachers weren't allowed to wed at the time.

"They ran off to Missouri and kept it quiet for a year or two," McKennie savs.

And the house? It now serves as a museum, as well as a testament to the generations who lived, loved and laughed within its walls.

# **STEWART** keeps busy helping others

No better time than today to "dive in," he says.

"If you want anything done, ask a busy man to do it." - Elbert Hubbard, 1856-1915



Bob Stewart is a busy guy. But, when you meet him, you'll quickly see that he's

busy helping others, not himself. Hang around, and you're likely to get "Bobbed," which is what his friends call being asked by Stewart to lend a hand in one of his many service projects. They also say it is almost impossible to say no.

Part of Stewart's success comes from his warm and engaging personality. He's like a magnet, drawing people to him because you just want to help him. He's also a master organizer. Once he spots a need, he will create the necessary infrastructure to fill it, whether it's a location, a sponsor, a donor, or an inside contact. In true "if you build it, they will come" style, Bob has volunteers lined up to support his projects.

When multiple hip surgeries made it impossible for Stewart to do overseas missions, he turned his attention to needs closer to home. One of the first programs he got involved with was Freedom for Youth. This is an after-school program for at-risk children in Des Moines. Stewart

formed a team of 12 people to prepare and serve a monthly dinner for the elementary and high school students.

"They were mostly grandmothers," Stewart says of the volunteers. "They enjoyed preparing and serving the meals — and the happy chatter of the kids as they enjoyed the meal."

Stewart is also involved in Meals from the Heartland. This organization prepares meal kits containing items like rice, beans and vitamins. The meals are hermetically sealed, loaded on pallets, and shipped all over the world. Bob organizes a group of 60 people to work once every six months to package more than 25,000 meals.

As if this were not enough, Stewart is also passionate about helping Central Iowa Shelter and Services, which takes in up to 300 homeless folks every day. They are always looking for help getting meals ready and served to them three times a day. Stewart has been using his connections with local businesses like Chick-fil-A and Friedrichs Coffee in Urbandale to donate sandwiches, coffee and even an industrial coffee machine to make a real difference.

Stewart likes to ask people he meets a thought-provoking question: "At what point in your life do you move from success to significance?" His answer? "Today!"

"Why wait?" he asks. "There's always a need; find what you're passionate about and dive in."

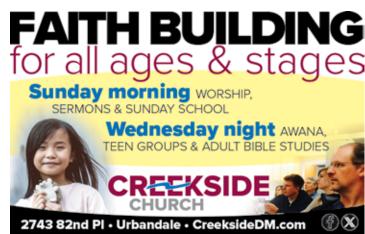

### **THE CONNECTION** between stress and chronic pain

Stress isn't just an emotional experience — it can have a profound impact on the body. When stress levels rise, the body releases hormones like cortisol and adrenaline that prepare us for "fight or flight." Over time, this constant state of alertness can lead to muscle tension, shallow breathing and changes in posture. This month, I share another recipe from my daughter, Samantha. She loves to make all kinds of bread. Few things make a kitchen feel more welcoming than the aroma of freshly baked bread, and parmesan



garlic focaccia delivers that comfort in every bite. Golden and crisp on the outside yet soft and airy inside, this Italian favorite is elevated with the irresistible pairing of roasted garlic and nutty parmesan cheese. It is the kind of bread that feels special but is surprisingly simple to make at home. Serve as a side with soups and pastas, cut into squares for an appetizer board, or enjoy warm right out of the pan. Focaccia is versatile and crowd pleasing. The drizzle of olive oil, a sprinkling of herbs and the cheesy finish give it that bakery-style touch you will love sharing — or keeping all to yourself. Enjoy! ■

#### Parmesan Garlic Focaccia Bread

#### **Ingredients:**

- 1½ cups warm water (about 110°F)
- 1 tablespoon sugar
- 21/4 teaspoons instant yeast (1 packet)
- 4 cups flour
- 1½ teaspoons salt
- 1/3 cup extra virgin olive oil, plus more for greasing
- 3 cloves garlic, minced
- 2/3 cup freshly grated Parmesan cheese
- 1 teaspoon dried Italian herbs or chopped rosemary
- · Flaky sea salt

#### **Directions**

- Combine warm water, sugar and yeast. Let sit for 5 minutes until foamy. Add flour and salt. Mix until dough forms. (It will be sticky.) With a mixer, kneed for 5-7 minutes or by hand for 8-10 minutes until smooth. Brush dough with olive oil and cover.
- Let rise 1-1.5 hours in a warm spot until dough has doubled.
- Heat 2 tablespoons olive oil with minced garlic until fragrant (about 1 minute) in a

pan. Keep for later.

Place dough in greased 9-inch by 13-inch pan. Gently press to corners. Let rest 10 minutes, then stretch. Cover and rise 30-45 minutes.



- Preheat oven to 425 F. With your fingers, dimple the dough all over. Brush with garlic oil. Then sprinkle parmesan cheese, herbs and sea salt on top of dough.
- Bake 20-25 minutes until golden brown. Cool 10 minutes in pan, then transfer to wire rack
- Slice and serve warm. Store bread for two days at room temperature or freeze up to three months.
- · For the best results, follow these additional steps: Make sure your water is warm (110 F), not hot. For the best texture, let the dough rise completely. Use plenty of oil in your pan, as this will give your bread a crisp crust.
