HEAD-TURNING

Residents share their passion for restoring vehicles.

While some of us dream about one day owning that fresh-off-the-showroom-floor vehicle with its spotless exterior, dust-free dashboard, brand-new smell and scuff-free tires, others are looking for something quite different: potential. Where we see a rusty, broken-down or past-its-prime set of wheels, they see what will be after repairs, cleaning, fresh paint and hours of labor, frustrations and gratification. They see a dream car in the making.

American Austin – unique small car

The 1932 American Austin Bantam Roadster car. Have you heard of it? Have you seen one? Have you ridden in one?

If the answer is no, you're not alone. However, there is one of these special antique cars in West Des Moines, and it is owned by Robert Cunningham.

The rarity of the vehicle is one reason Cunningham purchased it. It's also one of the smallest cars ever made.

The car's top speed is 42 mph. The 13 horsepower engine makes for a leisurely ride. Cunningham declares that a riding lawn mower probably has more power. In comparison, a Toyota Prius is 121 horsepower, while a Ford pickup truck boosts up to 400 horsepower.

The 5-gallon gas tank gets about 50 mpg. With no water or fuel pump, the gas drains into the carburetor, cools off and cycles there. The tires are motorcycle sidecar tires.

Cunningham purchased the car initially because he wanted one he could manually push.

"When I was younger, I bought and sold antique cars. They nearly always broke down, and it was difficult to push a car when it broke down. I decided to find the smallest car I could," he recalls.

In 2000, he bought the car after extensive research. As an automotive historian, he found the history of the car. The Bantam Roadster was used to shuttle pilots during World War II, transporting them from the airfield for the Tuskegee Airmen.

After the war, the car was abandoned in an airplane hangar where it sat for nearly 25 years. Someone found it and restored it in 1958. Finally, Cunningham found the car through a car dealer's advertisement.

"The dealer sent me a notebook full of records from the day it sold. As an auto historian, I couldn't pass that up," he says.

Included in the history were photos of a family in the car, along with their 5-year-old and an infant. They documented how they drove across New York in the tiny car.

"He fashioned a car seat in the front of the dash, with the baby facing the driver, and drove across New York like that."

The car is rare. American Austin only sold the car from 1930 to 1934 with 20,000 built. Only 1,550 in this particular model were made.

"There's only about 100 left in the world and only about 50 on the road," he explains. "The car cost \$285, which was a low cost at the time.

It was a popular car for parents to buy for their kids, who were students or young adults who needed a car instead of using the family car."

Cunningham takes the car to various car shows and gets many comments and looks as he

drives along.

"It's different. You go to a car show, and there's dozens of Corvettes and Camaros. You don't ever see these," he says as he points to his car. "There's only two in Iowa that I know of."

Cunningham's love of old cars started when he was a teenager. As he worked on his paper route, he noticed a dusty car with flat tires in a barn and asked if it was for sale. He made a deal for the 1936 Chevy and took out a loan for \$200.

In college, he drove a 1927 Willys-Knight. When he spotted a 1952 Packard on a street — a much newer ride than his — he asked the owner if it was for sale.

"I'd been taking photography classes. I gave him all of my photography equipment and a dollar and traded it for a Packard," he recalls.

He joined a Bantam Car Club in 1979 and began researching the unique cars. He spoke with people at factories where the cars were manufactured. He and his wife became the newsletter editors in 1980.

With more than 1,000 pages of research, he's written books about the history of cars, including the book "Orphan Babies — America's Forgotten Economy Cars." Since then, he's written and illustrated seven books detailing various car histories about small and economy cars.

He's adept at engine work, taking apart cars and putting them back together — correctly.

"I've had to do most of the work myself. Most shops won't touch a car like this," he says.

He continues to write the newsletter and research auto history as much as possible. His dream car is a 1936 Auburn Boattail Speedster.

"But it's out of my league," he says.

For now, his small car is the perfect size, as it doesn't take up much room.

"I can tuck it under my work bench in my garage," he laughs.

Mercedes in the '80s

As a young, single man in the 1980s, Terry Bolson, like other friends in that decade, desired a speedy car that conveys fun and excitement. A sporty car unlike his parents' vehicle. One that stood out.

The local car dealers didn't have the exact car he was searching for, so he looked in a catalogue for cars not available in the United States. He found a 1980 Mercedes 230 LE, owned by two people in Germany. The car, still in Germany, was shipped to the States to Bolson in 1985.

"I got a better price to buy it there and have it shipped," he says. Price wasn't the only factor. It was a unique find.

"It was a four-speed manual that you couldn't get in the U.S.," he says.

He also chose a Mercedes — one of the oldest car manufacturers — because it was a status car.

"Back in the day, when I was young and single, everyone wanted a cool car."

Another distinct feature is that it's a twodoor Mercedes, which he rarely sees on the road.

"It's rare to get a two-door. I remember all the college professors had four doors."

As it's a solid car, it came with seatbelts and a power sunroof.

"There's no post, so when you roll the windows down and have the sunroof open, it's almost like it's a convertible," he says.

Since it's a manual four-speed, Bolson says he is more engaged when driving.

"It's a lot more fun to drive with a manual than an automatic," he says.

Mercedes is a solid brand, and he hasn't had to make many repairs or updates. He put in a passenger's side mirror, a wood shifter and a stereo with a CD player — a must-have in that era. Although it's an older car, it's still fairly



easy to get parts if needed, he says.

A new grill was necessary when he hit a deer with the car. As he was driving one midafternoon, just four blocks from his house, a deer ran into his car.

"I ended up harvesting the deer and eating the meat," he recalls.

Although it's just a two-door, he says the back seat is roomy.

"You can seat five in the car. That's the same room as a new car, such as a Camry or Accord. The windows are lower, too."

It's also a fast car.

"I've had it up to 100 mph," he admits. "It's solid and built like a tank. When I slam the door, it's like a big thud."

Bolson takes it to various car shows, such as Cars and Coffee Des Moines, a meet-up with other vintage car owners at various places or parking lots in the Des Moines metro area. He gets a lot of looks and attention.

"People always question, 'What is that model?' This is so rare. I've never seen a white model anywhere."

People — mostly thieves — are enamored with the hood ornament. The signature

Mercedes round logo, which sits atop the hood of his car, has been stolen five times. He's replaced it each time.

"I try to park away from other cars and watch where I go," he says.

He's traveled the Midwest with his Mercedes but now is a leery of driving it too far and possibly breaking down a long distance from a shop that can fix it. His everyday car is an Acura, with 204,000 miles on it, which he says he will drive until it dies. He says he also plans to keep the Mercedes forever.

However, if he could ever find a 1970 Cougar convertible in mint condition, he'd consider buying it.

"I probably couldn't afford it," he says. "I'm pretty happy with this car." ■

HEALTH Insurance Terms 101

We all know how confusing health insurance can be with its continuously changing components. Understanding the basic lingo can go a long way in easing the confusion and feeling comfortable with your benefits.



Premium - The amount that must be paid for your health insurance or plan.

Deductible - The amount you pay for covered health care services before your insurance plan starts to pay. With a \$2,000 deductible, for example, you pay the first \$2,000 of covered services yourself.

Co-insurance – The percentage of costs of a covered health care service you pay (for example, 20%) after you've paid your deductible.

Out-of-pocket maximum - The most you have to pay for covered services in a plan year (for example, \$6,000). After you spend this amount on deductibles, copayments and

coinsurance for in-network care and services, your health plan pays 100% of the costs of covered benefits on Affordable Care Act (ACA) plans.

Copayment – A fixed amount (for example, \$20) you pay for a covered health care service, usually when you receive the service. Copayments (sometimes called "copays") can vary for different services within the same plan, like drugs, lab tests, and visits to specialist providers.

Network - The facilities, providers and suppliers your health insurer or plan has contracted with to provide health care services. You will come to find there are many different types of networks when you are shopping health insurance plans:

• Preferred Provider Organization (PPO): A type of health plan where you pay less if you use providers in the plan's network. You can use doctors, hospitals, and providers outside of the network for an additional cost.

• Point of Service (POS): A type of plan where you pay less if you use doctors, hospitals, and other health care providers that belong to the plan's network. You may go outside of the plan's network for health care services, but you will pay more of the cost.

• Health Maintenance Organization (HMO): A type of health plan that usually limits coverage to care from doctors who work for or contract with the HMO. It generally won't cover out-of-network care except in an out-ofarea emergency. HMOs often provide integrated care and focus on prevention and wellness.

Prior authorization - Approval from a health plan that may be required before you get a service or fill a prescription in order for the service or prescription to be covered by your health plan.

Step therapy – A coverage rule that requires you to try one or more similar, lower cost drugs to treat your condition before the plan will cover the prescribed medication.



A LOOK at diversification

Ancient Chinese merchants were said to have developed a unique way to manage their risk. They would divide their shipments among several different vessels. That way, if one ship were to sink or be attacked by pirates, the rest stood



Your investment portfolio may benefit from that same logic.

Diversification is an investment principle designed to manage risk. However, diversification does not guarantee against a loss. The key to diversification is to identify investments that may perform differently under various market conditions.

On one level, a diversified portfolio should be diversified between asset classes, such as stocks, bonds and cash alternatives. On another level, a diversified portfolio also should be

diversified within asset classes, such as a diverse basket of stocks.

A diversified approach

For example, let's say a stock portfolio included a computer company, a software developer and an internet service provider. Although the portfolio has spread its risk among three companies, it may not be considered well diversified, as all the firms are connected to the technology industry. A portfolio that includes a computer company, a drug manufacturer, and an oil service firm, however, may be considered more diversified.

Similarly, a bond portfolio that invests exclusively in long-term U.S. Treasuries may have limited diversification. A bond fund that invests in short-term and long-term U.S. Treasuries, plus a variety of corporate bonds, may offer more diversification.

Mutual Funds and ETFs

The concept of diversification is one reason why mutual funds and Exchange Traded

Funds (ETFs) are so popular among investors. Mutual funds accumulate a pool of money that is invested to pursue the objectives stated in the fund's prospectus. The fund may have a narrow objective, such as the auto sector, or it may have a broader objective, such as largecap stocks. ETFs also can have a narrow or broader investment objective. Keep in mind, though, the more narrow an investment objective, the more limited the diversification. Furthermore, a narrow investment objective may result in more volatility and additional risks associated with a particular industry or sector.

The concept of diversification is critical to understand when you are evaluating a portfolio.

OLD GLORY flies at Windstone

American flags for the holidays at Windstone

The Windstone neighborhood has started a new and patriotic tradition. On three summer holidays (Memorial Day, Independence Day and 9-11), every front yard in the community is decorated with American flags. The Windstone community is on the southwest corner of 60th and EP True Parkway in West Des Moines.

"Last year, a few of the owners, five or six homes, put them up on their own," says Linda Blackburn. "Many of us saw them, and I just went crazy, saying, 'Wouldn't that be fun if the whole community did that? If we could get that organized?' So, we went to work with our Homeowners Associations. We actually have two, for the separate cottage areas and then the gardens. So, we worked together with the two boards and got approval to purchase the flags — and we did that as a gift to our community."

After hundreds of 24-inch flags were purchased, Blackburn says, "We got a great group of volunteers, and our first venture was Memorial Day. The current plan is to display the flags on Memorial Day, Independence Day and Sept. 11."

Carol Smith, president of the Cottages homeowners association, said there was a lot of feedback from those living in the Windstone

neighborhood, and it was all positive. Smith added that some veterans who live at Windstone were particularly pleased with the patriotic display. Smith and Blackburn said they and five other volunteers spent roughly four hours putting the flags up, but they said it's worth it.

"We're still asking for volunteers," Smith says. "It's just a fun thing to do for our community."

"We're all doing it for the same reason," Blackburn says. "We want to always remember and always honor those who sacrificed ultimately for us. This is a way that the whole community can celebrate that together. And we're just having a lot of fun with it."

Both Blackburn and Smith agree displaying the flag should not be seen as a partisan gesture, but rather just showing pride in being American.

"We ended up putting in about 525 (flags for Memorial Day), but we're expanding out to the street on the 60th Street and EP True entrances, so we'll probably be closer to 560 (next time)," Blackburn says.

When asked how they made it all happen, Blackburn summarizes, "We didn't take 'no' for an answer. People were worried about the expense, of course. But we said volunteers will do all the work."

ABOUT guardianships for a child with a disability

If you are a parent of a child with a disability, and your child is about to turn 18, this can be a scary time. You may be aware that once a child turns 18, they are a legal adult and are presumed to be capable of making decisions and exercising rights on their own. This means that you, as the parent, will no longer be able to make decisions for your child regarding their finances, healthcare, or education.



In order to remain an active advocate for your child and to be included in conversations regarding their finances, healthcare and education, you should file for a guardianship over your child. A guardianship is a legal proceeding where a person, typically a family member, asks the court to find that the adult child is unable to effectively manage their affairs due to their disability.


To obtain a guardianship, you must petition the court. The petition must include all basic facts, including the petitioner's relationship to the person who will be under the guardianship as well as a brief description of the ward's disability. The description should include how the disability affect's the person's ability to make decisions. Following the petition, there will be a hearing before a judge. At this hearing, you must present sufficient evidence of the need for a guardianship.

A guardianship doesn't completely eliminate your child's ability to make decisions for themselves; rather, it provides you the opportunity to continue to support their self-sufficiency.

Having a guardianship over your adult child allows you to continue to support them and assist them in their everyday lives. You will, with a guardianship, be able to assist them in maximizing their independence. Without a guardianship over your 18-year-old, you lose the ability to speak with their doctors and care providers, communicate with insurance companies on their behalf, coordinate benefits, and assist in managing their finances and assets.

In order to ensure that your petition is done correctly and that you are maximizing your chances of continuing to be an advocate for your child, you should speak to a reputable attorney with experience in guardianships. Your attorney will be able to assist you in the petition and in any court hearings that follow.

CBD in water-soluble format

SEAL of Biliteracy award

31 students proficient in two languages

Thirty-one Valley High School students obtained a Seal of Biliteracy on their graduation transcript for 2023.

Natalie French, director of English for Speakers of Other Languages, says three of those students earned the Seal of Biliteracy in multiple languages. Student recipients demonstrated proficiency in English along with Amharic, Arabic, Chinese, French, Latin, Romanian, Russian, Serbian, Spanish, Telugu, Tigrinya and/or Ukrainian.

The State of Iowa's Board of Education offers the Seal. To obtain the designation, a student needs to demonstrate proficiency in two or more different languages, English and another language.

"Many different students attempt to earn the Seal of Biliteracy," says French. "Some students have been studying a world language for more than three years, through our district's world language program, outside coursework or independent study. Others are fortunate to be bilingual or multilingual students from linguistically diverse homes, where they've grown up speaking languages in addition to English."

She says the West Des Moines Community School District is a diverse community.

"Nearly one in four students and families are multilingual. Having students and staff with oral and written language skills in languages other than English facilitates communication, builds community and supports our student learning," she says. "It's an attractive skill for future employers and college admission offices."

Valerie Vera, who graduated with the seal, pursued the recognition to validate the knowledge, experience and skills she's developed throughout her life.

"I'm hoping to gain a tool which certifies the abilities I worked so hard to expand," she says. "In addition, this title will have a positive impact on any career path I decide to follow."

Vera uses both languages daily at a variety of places.

"When I translate information for my family, not only for them, but I'm also able to assist complete strangers who I find struggling to get their needs met due to the pre-existing language barriers," Vera says.

Vera says she believes the Hispanic population will continue to grow in the U.S.

"I would love to be part of the community willing to facilitate the transition from immigrants' old life to their new one," she says.

PERFORMANCE vs. planning

This month we are going to talk about investment performance in relation to a financial plan. 
PROCLAMATION notes mental health awareness
