**Question**

Shall the Board of Education of Santa Fe R-X School District of Lafayette County, Missouri, borrow money in the amount of One Million Nine Hundred Thousand Dollars (\$1,900,000) and issue general obligation bonds to pay costs of acquiring, constructing, equipping, furnishing and improving school facilities to include, without limitation, (1) improving building accessibility, including elevator replacement at the elementary school, (2) improving site access with pedestrian and vehicular safety upgrades, (3) exterior site lighting improvements and playground safety upgrades, including new fencing, (4) improving high school and elementary gymnasiums, including new flooring and bleachers, and (5) renovating the high school library/media center? If this proposition is approved, the adjusted debt service levy of the District is estimated to remain unchanged at seventy cents (\$0.7000) per one hundred dollars of assessed valuation of real and personal property.
