Public Before the Board

Ruth Thompson, 26 Scott Crescent: 13 Main St, is that a vape store? Is this what we want in our Village? Response – he has all permits required, CDB cannot be regulated, it is a protected crop. It is not marijuana. Sidewalk from Main St. to Legion property and the curve along Scott Crescent needs attention. Asphalt piled behind 39 Main St. That may be a violation of the DEC being so close to the creek. Code Enforcement Officer is aware. It is not affecting the creek. The millings will be used to repair the parking lot.

Public Hearing – Tax Cap Override

Mayor Ridge opens public hearing at 7:00 pm by reading the notice published in the Sentinel.

PLEASE TAKE NOTICE that a Public Hearing will be held by the Village of Scottsville Board of Trustees on Tuesday, April 8, 2025 at 7:00 pm to consider Property Tax Cap Local Law #3-2025 to Override the Tax Cap Levy Limit established in the General Municipal Law 3c for the 2025-2026 Fiscal Budget.

The Proposed Local Law can be reviewed at the Village of Scottsville Office, in the Wheatland Municipal Building, 22 Main Street, Scottsville, NY during regular business hours.

Treasurer Paula Parker gave an overview of the Tax Cap. First component is growth, how much did our assessed value go up in the past year? Determined by the Town Assessor, changed by new buildings and business. Second is inflation; the rate of inflation or 2%, whatever is less. This year, about \$12,970 is our tax cap this year. That's the 2%. That is not enough to meet our needs. The budget is \$12,530 over the tax cap. Two large expenses are driving the increase. First is the New York State Retirement System. All full-time employees must participate in the NYS Retirement. The state regulates our cost of retirement. The second is Health Insurance, we are too small to join a health insurance trust to reduce costs. We must buy from the community pool at a higher rate. Total increase is 5%, which includes the 2% tax cap. Based off the assessed value, the tax rate increase will be 3.5%, which equates to .16 per 1,000 or \$16 per 100,000. This law is passed every year, in the pass four years we have not gone over the tax cap. This year we are dealing with an increase in costs across the board. Go to the Comptroller's website to learn more.

Public Comment open at 7:09 pm

Ruth Thompson, 26 Scott Crescent Opposed to increasing the tax cap. We all have to live within our means and consider necessities vs. wants. Should look at the extras that can be cut to stay under the tax cap. SummerFest, flowers on Main St, and bands are not a necessity. Where are those people who want to see these events funded?

Julie Bowers, 24 Scott Crescent Opposed, we all need to live within our means.

Tony Gallo, 11 Scott Crescent People are tired of the burden of taxes, take a close look and separate need from wants.

Public comment closed and Board comment opened at 7:27 pm.

Mayor Ridge: Also, garbage, recycling and environmental fees have gone up, we are very limited on disposal. And the sales tax revenue is coming in lower. Will vote for the tax cap override because it is a safety net. There are a lot of projects coming down the pike, including work to Main St. We are looking at grants to do some of these projects, but grants are not guaranteed.

Trustee Fraser: Your comments have been heard, we hear from people on the street, Main St is deteriorating, and we are looking into grants to alleviate the burden. Every line of the budget we thoughtfully went through adding and subtracting, I believe it is important. Our Treasurer Ms. Parker did a great job with presenting, communicating and comparing the last five years. Employee raises were based on COLA. Confident this law should be passed. We all live here; we are part of this community. We are advocating on your behalf; the Board has forgone raises to keep the budget in check.

Deputy Mayor LaVair: When preparing the budget, we listen to what people feel the community needs and what brings value. Community events are necessary for community development and increase morale and make the community strong. Trying to revitalize these events to get more people involved in the community to keep it growing. We are doing the best we can and keeping the tax payer in mind.
