Open to ages 7 to 17, this unique opportunity is a great way for your child(ren) to experience entrepreneurship firsthand with real world experiences, in a safe and fun environment:

- Creativity – Deciding what type of product the public would be interested in purchasing
- Assessing and Managing Risk - Production or acquisition of the product requires investing money and time upfront with no guarantee of a return
- Math and Accounting - Calculating Cost (including materials, signage and time) of Goods Sold vs Revenue vs Profit
- Marketing- In addition to local Summerfest advertising, including your own Social Media channels, signage at the booth, greeting and encouraging customers to come to your booth
- Confidence – every interaction with the public will help build your child’s self-confidence.

We encourage parents and/or guardians to guide their young entrepreneur by allowing them to do a majority of the actual work, including the idea of what to offer, setting up the booth (or table), talking to customers, *taking payment and making change.

**There is no Wi-Fi or electricity at the park – if you’re accepting payment through an app (i.e. Venmo, Cash App, etc.) make sure to have a fully charged cellular device.*

Additional Terms and Conditions:

Children cannot sell on adults’ behalf.

No MLM’s

Parents or guardians must remain on site during the event

Booth areas must be left clean. Trash totes will be on site

No smoking or vaping permitted in the booths

Pets are not allowed, with the exception of service animals

Event Description:

This year's theme is 'Something for All' and will feature live performances, children's activities, local social groups, food, craft and direct seller booths, music, cornhole tournament, and more.

Johnson Park is a 6-acre park located in the middle of the Village, featuring several ballfields, a skate park, an indoor/outdoor pavilion with bathrooms, and plenty of free parking.

KidsMart Vendor information:

- Booth sizes: 10 X 10 Feet - \$ No Charge for KidsMart
- Pop up tents are not required, but please be aware – there is no shade in Johnson Park, so a market umbrella is advisable if no tent.
- If tents are used, they must be weighted and/or staked into the ground.
- Vendors will be responsible for bringing their own tables and chairs.
- No electricity or Wi-Fi available. If using an electronic app, the data use will be cellular
- Set up/Move in begins at 8:00 AM, cars must be off the field by 9:00 AM – Market opens at 10:00AM

Additional Information:

- Cars are allowed to pull up onto the lawn for set up but need to be parked in the lot behind the church during the event.
- This is a rain or shine event.
- Booths are on a first come, first served basis. We will do our best to inform vendors if there are other vendors with similar offerings. The KidsMart booths will be all together, in one designated area.
- Bathrooms are on site outside of the pavilion and are ADA accessible.
- Food will be available on site to purchase.

- Booth numbers, map and move in/move out instructions will be emailed to you beginning July 13, 2026.
- If the child isn't available, please provide a sign "Be Back Soon"
- Please note that we reserve the right to deny the sale or display of any items not deemed appropriate at a community event. **Any food products must comply with the Monroe County and NYS Food and health rules along with the requirement of a copy of your Health Permit attached with the application. NO SALE OF CBD AND OR CANNABUS BASED PRODUCTS, OR EXPLOSIVE DEVICES OF ANY KIND ARE PERMITTED. No open flames allowed in the park.**
