Resolution of Authorization and Project Costs for Award Allocations

WHEREAS, the Village of Scottsville submitted and was awarded an Engineering Planning Grant (EPG) under the Consolidated Funding Application (CFA) process on behalf of the Village, for a sewer improvement study; and

WHEREAS, the New York State Department of Environmental Conservation and the New York State Environmental Facilities Corporation offer a competitive statewide reimbursement grant programs for local governments, administered through the New York Clean Water State Revolving Fund; and

WHEREAS, that the Village of Scottsville Board of Trustees, accepts the EPG program grant award on behalf of the Village for the sewer improvement study; and

NOW THEREFORE BE IT RESOLVED, that Mayor Eileen Hansen is authorized to execute a Grant Agreement with the NYS Environmental Facilities Corporation and any and all other contracts, documents and instruments necessary to bring about the project and to fulfill the Village of Scottsville's obligations under the Grant Agreement; and

BE IT FURTHER RESOLVED, that the Village of Scottsville authorizes and appropriates a minimum 20% local match as required by the Engineering Planning Grant Program for the Sewer Improvements Study. Under the EPG program, this local match must be at least 20% of the EPG grant award of up to \$30,000. The source of the local match, and any amount in excess of the required match, shall be provided through the general fund. The maximum local match shall not exceed \$6,000 based upon a total

estimated maximum project cost of \$30,000. The Mayor may increase this local match through the use of in-kind services without further approval from the Village Board.

NOW THEREFORE BE IT RESOLVED, that the Village of Scottsville hereby determines that the proposed Sewer Improvements Study is a Type II action in accordance with 6 NYCRR Section 617.5(c) (24) and (27) which constitute "information collection including basic data collection and research, water quality and pollution studies, traffic counts, engineering studies, surveys, subsurface investigations and soils studies that do not commit the agency to undertake, fund or approve any Type I or Unlisted action; conducting concurrent environmental, engineering, economic, feasibility and other studies and preliminary planning and budgetary processes necessary to the formulation of a proposal for action, provided those activities do not commit the agency to commend, engage in or approve such action" and is therefore not subject to further review under 6 NYCRR Part 617.
