Q from Lisa Wasson: Do you feel state will force a consolidation?

A Chief Brown: Scottsville, Caledonia and Mumford work well together but Scottsville would need to be a district first before merging.

Ray DiRaddo added that state does not force consolidation. Two ways to consolidate, by board resolution or resident vote. The first year Commissioners would be appointed until end of calendar year. Before end of year there would be a vote and top five would become Commissioners with differing terms (i.e. highest vote would get 5-year term, 2nd highest would get 4-year term etc. so each year would only need to vote for one commissioner position).

Q from Christie Offen: How are the newer Fire Districts doing?

A Chief Brown: They are doing well and seem to be financially stable. They have five people that make the decisions along with help form the fire chief and seems to be a well-oiled machine.

Q from Linda Dobson: Does state put limit on % of spending year after year?

A from Ray DiRaddo: 1st year no tax cap. 2nd year is subject to tax cap. 3rd year subject to spending limitations which could only be overridden by mandatory referendum by the public.

Linda Dobson explained the Town collects the fire tax and there is separate line item on Town tax bill that itemizes spending for Fire District.

Opened for questions from the public

Q from Ben Deragon How will taxes be affected?

A Too early to tell at this point. Will discuss more in the next meeting.

Q from Ted Raden: What is potential revenue for households in this district and what % per thousand would be a good place to start?

A: Too early to know. In the early stages of putting out information and trying to keep discussion on info presented at this meeting. More to be presented at next meeting.

Q; Will Town and Village reduce taxes to offset additional fire taxes?

A: Too early to decide that at this time.

Q: Can village support fire district without the town?

A from Mayor Hansen: No
