#### **Complaints**

May 8<sup>th</sup> 2018 Apartment 14A Main Street tenant walked into the Village and complained about problems with their apartment that the landlord will not take care of. Their electric is running lights to the upstairs apartment. They have missing drywall ceiling in their bathroom, kitchen still has black residue from the fire smoke damage of a year ago, there is a water leak coming in from the front of the home over the west living room window. I have called National Grid to look into the electric meter sharing problem. Apartment 16 does not have an operating furnace since April 27<sup>th</sup>. I spoke to the landlord about these same problems last month and he told me that they were all taken care of. I have written a letter to the landlord with the list of complaints that are to be finished within 30 days of May 4<sup>th</sup>, 2018.

On May 22<sup>nd</sup> National Grid was at the property doing a "Shared Service" testing of the property. The final results are not back yet. As of the inspection day National Grid found that Penny Smith's Apartment 14A Main Street has been powering the exterior hall light as well as the basement lights and the sump pump. All other findings will be issued in the National Grid report that will be sent to our Village office.

May 22, 2018 Neighbor of 67 Rochester St. said that a car was parked up against his fence of his residence at 4 Grove Street. There are no plates on the car. I called the present renter who gave me the owner's name and phone number. I contacted the owner who said he would contact the previous renter to have the cars removed by the end of the month. By May 22, 2018 the car had been removed from the property.

### **Continued Complaints**

Mr. Jeff Holt (bordering neighbor to the west of Coopervision) and two other neighbors have been complaining about Cooper vision's new addition that has air compressors in it. When the compressors are on they are very loud and blowing air out of large vents in the wall of the building facing Mr. Holt's property. Mr. Holt and his two neighbors are writing to the Board making a formal complaint with a lawyer. I spoke to the construction manager of the addition they completed to house the compressors and relayed him the problem. He was receptive to the problem and suggested they plant Arborvitaes or install a solid 6-foot-high fence.

The construction supervisor that finished the compressor building is the same person running the construction of the cafeteria that was started the last week of May.

**<u>Resolved Complaint</u>** The neighbors have been complaining about loud college students renting 3 Oatka Place. I have contacted the owner by phone and email. I contacted the residents that were complaining and the college student renters are now not making noise late at night and into the morning anymore.

# Mayor's Report - Eileen Hansen

Liaison to: Fire Department

A young man came in the office to start a petition to get a bike rack in front of the library.

#### **CHS**

Mayor Hansen: Approached by CHS to open negotiations to obtain a contract, Mayor Hansen and Mr. Nafus will meet and hope to have an ambulance service contract that will be helpful to the community and give added benefits besides ambulance service. Will be looking at that and giving the Board updates throughout the process.

Trustee Shero: Why are we doing this when they come here anyway?

- E. Hansen: Certificate of need brings the ambulance; a contract will bring more, such as no co-pays
- T. Shero: Pay a fee for the contract that will pay the co-pays.
- E. Hansen: Looking at other contracts, there is a yearly fee for the contract and out of that fee will be taken the copays, if our call volume is low they will reduce the contract fee, have CHS come to an information meeting, anybody on Medicare would have no out of pocket expenses.
- T. Shero: There again using tax payer money to subsidize people on Medicare.

Deputy Mayor Carl: We have ambulance money that tax payers put into.

- T. Shero: That was our own ambulance service.
- K. Carl: Then the ambulance was dissolved and the money was put in the Fire.
- T. Shero: Giving money to a company that is making a fortune so that my neighbor without health insurance can get a free ride.
- E. Hansen: That is not what this is about.
- T. Shero: That is what we are talking about.
- E. Hansen: That is, but there are more aspects to this.
- T. Shero: Who are we dealing with in the negotiations of CHS?
- E. Hansen: Reg Allan and Matt Jarrett, I plan to talk with them to see what they are offering. From what I've been told it's just not people on Medicare it also covers regular insurance as well. I want to know what benefits there are, how large a group in our community it will affect, and will it help. We will have an informational meeting for the public.

Trustee Offen: I was intimately involved in the contract negotiations and the whole process last year and I was not impressed, unless something majorly changes to change my mind I think it is poor timing because we don't have the money. It is expensive.

- T. Shero: We've got people collecting donations to make Main St. pretty, we've got people who are under water for years on end and we can't give them a resolution down on Scott Crescent. And now shell out \$30,000 40,000 a year for an ambulance contract for service we are already getting and they have to provide legally.
- E. Hansen: It's something I want to investigate and see what they can offer our community and if our community wants it.
- K. Carl: Let the public determine what they want.

Resident C. Kendrick Please include numbers at the information meeting. How much it is going to cost.

Trustee Offen: Copays is a big sticking point. We didn't get a good resolution on that and that's why it went south, for many reasons, but that in particular.

E. Hansen: It doesn't hurt to look at it again and see what they can offer.

Resident T. Dunn: We all pay the same tax dollars to cover all services that some get more off and some get less of.

T. Shero: People complain about the taxes going up now we are talking about adding another \$30,000-40,000 a year.

Trustee Offen: That we did not budget for.

- T. Shero: We'll let the tax payers decide.
- E. Hansen: Is there money from the EMS line that is slated for EMS? There are a lot of things to look at, nothing has been decided yet. The community will have a chance to give their input.
