# SECOND AMENDMENT TO INTER-MUNICIPAL CONTRACT

THIS CONTRACT is made by the TOWN OF WHEATLAND, a Municipal Corporation with offices at 22 Main Street, Scottsville, New York (hereinafter called the "TOWN"), and the VILLAGE OF SCOTTSVILLE, a Municipal Corporation, with office at 28 Main Street, Scottsville, New York (hereinafter called the "VILLAGE"), collectively the Parties as follows:

WHEREAS the Town and the Village entered a contract dated March 14, 2005, and. And Amendment to the contract dated January 13, 2006, and parties desire to amend the contract and the amendment to the contract as follows;

The Village is to obtain and provide a certificate of liability insurance to the Town annually . in an amount equal to or higher \$1,000,000 in General Liability coverage.

Such certificate shall name the Town of Wheatland as "Additional Insured" by endorsement that provides primary and non-contributory coverage for general liability.

The Village hereby covenants and agrees to indemnify, defend and hold harmless Town and its officers, agents and employees from and against any and all claims, liabilities, obligations, damages, losses and expenses whether contingent or otherwise, including reasonable attorney's fees and costs of defense, incurred by the Town as a result of the Village's acts pursuant to this agreement and any amendments thereto. The Village as part of its obligation to indemnify and hold harmless, as set forth above, agrees to obtain, and maintain in full force and effect, for the term of this agreement, insurance coverage as described above.

The contract terms in the contract dated March 14, 2005, and the amendment to the contract dated January 13, 2006, shall remain the same expect as modified herein.

WITNESSETH, that the said party of the first part has agreed to LET, and hereby does LET to the said party of the second part, and the said party of the second part has agreed to TAKE, and hereby does TAKE from the said party of the first part, the following premises, viz: one assigned parking spot at the west end of the Town parking lot in order that the Village of Scottsville may place a cardboard recycling dumpster for the benefit of an owner of the business on 11 Main Street in said Village, with the privileges and appurtenances for and during the term of one year from the 1 <sup>st</sup> day of January, in the year 2023, which term will end on the 31 <sup>st</sup> day of December, in the year 2023.
And the said party of the second part covenants that they will pay to the party of the first part for the use of said premises the rent of One Dollar and other good and valuable consideration.
That the Village shall keep the area clean of any refuse and other materials. The dumpster will be locked at all times. Failure to keep the area clean will result in a ten-day notice to remove the dumpster and terminate the lease.
