SEQRA Resolution Village of Scottsville, Town of Wheatland and Irondequoit Bay South Central Pure Waters District Intermunicipal Construction and Service Agreement

RESOLUTION

WHEREAS, the Village of Scottsville (the "Village"), the Town of Wheatland (the "Town"), and Irondequoit Bay South Central Pure Waters District previously entered into an intermunicipal construction and service agreement regarding the Village and Town sewerage systems dated August 2, 2012 (the "Agreement"); and

WHEREAS, the Village and Town desire to amend certain sections of the Agreement regarding billing and logistical implementation of the Agreement (the "Amendment"); and

WHEREAS, in accordance with the New York State Environmental Quality Review Act, Article 8 of the Environmental Conservation Law and the regulations adopted pursuant thereto at 6 NYCRR Part 617, as amended (collectively referred to as "SEQRA"), the Village must satisfy the applicable requirements set forth in SEQRA, as necessary, prior to making a final determination whether to undertake the Amendment; and

WHEREAS, the Village Board of Trustees has completed its review of Parts 2 and 3 of the Short Environmental Assessment Form ("EAF"); and

WHEREAS, the Village Board of Trustees has given consideration to the criteria for determining significance as set forth in 6 NYCRR § 617.7(c) and the information contained in Parts 1, 2 and 3 of the Short EAF.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF SCOTTSVILLE AS FOLLOWS:

Section 1. The Amendment is classified as an Unlisted Action as it does not exceed any existing thresholds of the Type I list as established through 6 NYCRR § 617, and each of the Whereas Clauses in this Resolution are incorporated by reference as specific findings of this Resolution and shall have the same effect as the other findings herein.

Section 2. The Village Board of Trustees has considered the significance of the potential environmental impacts of the Amendment by: (i) carefully reviewing and examining the responses to the Short EAF, and completing the analyses for Parts 2 and 3 of the Short EAF, together with examining other information and documents concerning the Amendment, to identify the relevant areas of environmental concern with respect to potential impacts to land, geological features, stormwater and groundwater, wetlands, flooding, air, historic, archaeological and other recognized and/or protected resources, plants and animals, including threatened or endangered species, noise, odor, or light, human health, critical environmental areas, open space and recreation, aesthetic resources, transportation, agriculture, community character and cumulative impacts, if any, and other potential impacts as required by applicable regulation; (ii) considering the criteria set forth in 6 NYCRR § 617.7(c); and (iii) thoroughly analyzing the identified areas of relevant environmental concern.

Section 3. Based upon a review by the Village Board of Trustees of the Short EAF and supporting information and documents concerning the Amendment, the Village Board of Trustees hereby finds that the Amendment will result in no potential significant adverse environmental impacts requiring the preparation of an environmental impact statement for the Amendment. The Village Board of Trustees thus issues a Negative Declaration for the action pursuant to 6 NYCRR § 617.7. The reasoning supporting the Village Board of Trustees' determination of significance for the Amendment is more fully set forth in the Part 3 Determination of Significance.

Section 4. The Village Board of Trustees accepts the findings contained in Parts 2 and 3 of the Short EAF and directs the Mayor to sign and date Part 3 of the Short EAF.

<u>Section 5.</u> The requirements of SEQRA have been satisfied and this Resolution shall take effect immediately.

Amendment to Village/Town and Irondequoit Bay South Central Pure Waters District Intermunicipal Construction and Service Agreement

Page 4 Construction Paragraph 2 replacement

2. The VILLAGE will finance all VILLAGE/TOWN costs including but not limited to, costs associated with planning, design, construction, inspection, engineering, legal, administration, and other costs of the LOCAL PROJECT and REGIONAL PROJECT. These costs are estimated to be \$3,590,000 as shown on Exhibit C. The VILLAGE shall calculate both VILLAGE and TOWN shares of the annual debt service payment each year based on the number of "EQUIVALENT DWELLING UNITS" ("EDUs") located in each municipal jurisdiction in that year. The VILLAGE and TOWN EDUs will be expressed as percentages of the total number of combined VILLAGE and TOWN EDUs applied against the annual debt service payment. The VILLAGE and TOWN list of EDUs shall be reviewed by a Scottsville Wheatland Regional Sanitary Sewer Committee (SWRSSC) every two (2) years, or as residential and/or commercial projects materially increase the flow. The SWRSSC shall be comprised of six (6) members as follows:

The TOWN Code Enforcement Officer.

The VILLAGE Code Enforcement Officer.

A VILLAGE Board member

The TOWN Highway Superintendent.

The VILLAGE Department of Public Works Superintendent.

The VILLAGE Treasurer.

As of the date of this Amendment, the current percentage of EDUs is calculated to be 72% EDUs in the VILLAGE and 28% EDUs in the TOWN. This percentage shall remain in effect until a review by the SWRSSC determines that the difference in either of the calculated percentages exceeds 1%.

3. The VILLAGE shall invoice the TOWN semi-annually by January 1st and July 1st for the TOWN share of the annual debt service payment for the cost of the LOCAL PROJECT and REGIONAL PROJECT. Upon receipt of this semi-annual debt service invoice, the TOWN shall pay the VILLAGE by means of a lump sum payment. The TOWN shall pay semi-annually by February 1st and August 1st.

SERVICES (p. 6)

Delete "This EDU proportion shall be reviewed and updated annually by the SWRSSC, and this proportion shall not be challenged by either the VILLAGE or TOWN."

Insert "This EDU proportion shall be reviewed and updated by the SWRSSC every two (2) years or as residential and/or commercial projects materially increase the flow. The proportion may not be challenged by either the VILLAGE or TOWN, unless such proportion deviates from the proportion set forth in the prior year by greater than 50%."
