# Local Law No. 1 of the year 2024

# Village of Scottsville, County of Monroe

# A local law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c

Be it enacted by the Board of Trustees of the Village of Scottsville as follows:

# Section 1. Legislative Intent

It is the intent of this local law to allow the Village of Scottsville to adopt a budget for the fiscal year commencing 2024 – 2025 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

# Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

# Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Scottsville, County of Monroe, is hereby authorized to adopt a budget for the fiscal year commencing 2024 – 2025 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

# Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

# Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

# Memorandum of Understanding

Between the

# **GWA Chamber of Commerce, Inc.**

and the

# Village of Scottsville, New York

The <u>GWA Chamber of Commerce, Inc.</u>, (hereinafter referred to as the CHAMBER) and the Village of Scottsville, New York (hereinafter referred to as the VILLAGE) wish to define the ownership for Genesee Valley Trail Town (GVTT) amenities installed in Canawaugus Park, Scottsville New York as part of the 2022 Wheatland Scottsville GVTT grant project by way of this Memorandum of Understanding (hereinafter referred to as the MOU). This MOU also defines maintenance and repair responsibilities for these GVTT amenities including: an informational kiosk, a bicycle rack, a bicycle repair station and wayfinding signage.

WHEREAS, the CHAMBER is a New York Nonprofit Corporation with formal governance provided in accordance with the organization's By-Laws as a set of policies, practices and mechanisms by which the organization is directed, controlled and financially managed through a duly elected Board of Directors.

WHEREAS, the VILLAGE is a municipality located in southwestern Monroe County, New York, United States, and is in the northeastern part of the Town of Wheatland. The municipality is governed by a Mayor and other members of a Board of Trustees.

WHEREAS, the Wheatland Trail Town Committee is a volunteer only Committee, that was formed by the Town of Wheatland municipality, with the mission to support the establishment and ongoing activities of the Town of Wheatland as a GVTT Community. As a volunteer supporting organization without formal authority, it is anticipated that the Wheatland Trail Town Committee will support specific GVTT amenities maintenance activities in accordance with its mission such as:

- Development of a GVTT amenity inspection checklist to support semi-annual
  inspections to include physical conditions of the amenities defined above including the
  information kiosk structure, including the panels, the base, and all content that's
  integrated into the panels.
- 2. Report any physical damage of the GVTT amenities to the **VILLAGE** Clerk so repairs and/or maintenance issues can be addressed.
- 3. For the informational kiosk, update referenced online Wheatland GVTT content as appropriate.

# NOW, THEREFORE, the CHAMBER and the VILLAGE, hereby mutually agree as follows:

#### 1. The VILLAGE shall:

- a. Assume full ownership of the GVTT amenities referenced above and accept the maintenance and repair tasks as outlined below. In addition to ownership and maintenance, insurance coverage on the GVTT amenities shall be the sole responsibility of the VILLAGE.
- b. Maintain the GVTT amenities in good, functional order including the land underneath the informational kiosk. This includes mowing, weed whacking, and keeping the 4 panels clean and legible. The VILLAGE shall have the right to take over anticipated GVTT amenity maintenance responsibilities of the Wheatland Trail Town Committee or remove the GVTT amenities if such maintenance activities are no longer practical.
- c. Repair damage to the GVTT amenities (including but not limited to damage from normal causes, accidental damage caused by people or animals, vandalism, and/or other causes) whether or not the cost of the repairs is covered by insurance. If the cost of the repairs is prohibitive, fundraising may be employed by the VILLAGE to raise the funds. The VILLAGE shall have full right to remove the any or all of the GVTT amenities if the cost of the repair cannot be borne by the VILLAGE or other reasonable means of funding, or if there is a public safety issue.

#### 2. The CHAMBER shall:

The parties are in agreement on this date:

a. Transfer sole ownership of the above referenced GVTT amenities to the VILLAGE, upon this MOU being fully executed with the signatures below.
