

## **Indianola Country Club Corporate Membership**

Thank you for taking advantage of our Corporate Membership. For your staff to get off to a good start we feel it would be good to educate them on a number of items.

### **Golf Course Dress Code**

At Indianola Country Club we want all our members and guests to have an enjoyable experience during their round of golf. The membership at Indianola Country Club prides themselves on having a private club experience with affordable prices. The goal at our club is to allow casual dress with the understanding that we are a private facility. Muscle shirts, tank tops, un-hemmed cut offs and tee shirts with graphics are not allowed. A solid-colored tee shirt without graphics and in good condition is allowed. However, outerwear pieces, such as sweatshirts, will be allowed with graphics if the graphics are not inappropriate. A collared golf shirt and golf-related layering piece is our preferred choice. Our female members and guests are allowed to wear sleeveless golf shirts designed for the golf course. Female golfers must wear a top and bottom that doesn't reveal too much. Again, we want our dress code to be relaxed but not to the point that others find it distracting, disturbing or inappropriate. Golf Shoes or golf sandals with soft spikes or athletic shoes must be always worn while playing. Members and guests are not allowed to play barefooted or with footwear that could damage the grass plant. It is every member's responsibility to make sure their guests are aware of our dress code policy on the golf course.

### **Clubhouse Dress Code**

At Indianola Country Club we want all our members and guests to have an enjoyable and relaxed experience. Muscle shirts, tank tops, un-hemmed cut offs, dirty and poor conditioned clothing, any piece of apparel with inappropriate graphics or suggestive sayings are not allowed. Our goal is to give you every opportunity to enjoy your clubhouse experience in a casual yet neat appearance. It is every member's responsibility to make sure their guests are aware of our dress code policy prior to entering the clubhouse.

### **Men's Day & Ladies Day**

Ladies Day is observed from June – August on Wednesday's. Men are allowed to play but must be teed off by noon and off the course by 4:00 p.m.

### **Tee Times?**

Reservations, or tee times, are highly recommended. Those authorized to utilize this corporate membership should contact PGA Golf Professional Jason Marvelli to get set up and instructed on how reservations for golf can be made.

### **Signing In**

When you arrive at the course you will need to check in on our lower level. The Mulligans staff at the club will need to get all the names of those players utilizing the corporate membership on this day.

### **Pace of Play**

Indianola Country Club prides itself on a quick pace of play. We educate our members that if there is a group behind you waiting and there is an open hole in front of you, you'll need to allow this faster group to play through.

## **Golf Carts**

Your corporate membership includes cart rental. Carts must obey the 90 degree rule at all times. Carts must return to the cart path once you're 30 yards from the green. Carts must remain on the cart path on all par 3's. Please check the signage by the first tee for the cart rules for the day. If it reads Cart Path Only you are not allowed to leave the cart path at any time for any reason.

## **Alcohol – Food & Beverage**

Iowa Law prohibits you from being able to bring your own alcohol. Indianola Country Club prohibits you from bringing any food and beverage as we provide these services.
