Thank you for choosing us as your hearing provider. We are committed to providing you with quality and affordable hearing care.

INSURANCE: We participate in most insurance plans. If you are not insured by a plan we are contracted with, payment for your services is expected at your visit. If you are insured by a plan with which we are contracted but, do not have an up-to-date insurance card, payment in full for each visit is required until we can verify your current coverage. Knowledge of your insurance benefits and eligibility is patient responsibility. Please contact your insurance company with any questions you may have regarding your coverage.

CO-PAYMENTS AND DEDUCTIBLES: All co-payments and deductible/co-insurance must be paid at the time of service. This arrangement is part of your contract with your insurance company. Failure on our part to collect co-payments and deductibles from the patient can be considered fraud. Please help us in upholding the law by paying your co-pays at each visit. If you are unable to pay at the time of your appointment, we will be happy to reschedule.

NON-COVERED SERVICES: Please be aware that some (and perhaps all) services provided may be, as described by your insurance company, non-covered or not considered reasonable or necessary by policy standards. You must pay for these services in full at the time of visit.
