- Volunteer of the Year: 18+ years of age and active volunteerism in church, schools, community, programming, etc. and their volunteerism is not a part of their paid employment
- Business Woman of the Year: 21+ years of age, a leader in her field with an established career for a minimum of 3 years

- Potential awardees may be nominated by anyone or may nominate themselves. Please do not nominate anyone for multiple categories.
- The nomination narrative should specifically be formatted and address questions for the Women in Business Awards. If it is written as a nomination for another award, it will not be given to the judges for consideration.
- A submission of a resume or list of nominee's accomplishments/service does not meet narrative requirements. Please review "Tips for a Great Nomination" suggestions on writing nomination narratives and letters.

The deadline to submit this application is March 31<sup>st</sup>, 2022.
