5. Nomination for Meeting Chairperson to run the caucus meeting (needs a second and a voice vote)
6. Clerk reads the Nomination Procedures
7. Discussion on Method of Nomination – Voice, Hand or Paper
8. Discussion and Determination Vote on Counters – to reach a maximum of two (2) ballot counters
9. Discussion if there is a tie for the 2nd person for a position and how a tie is broken (regarding vote or drawing lots)
10. Nominations/Seconds/Voting as needed for the following Board Offices:
 - a. Up for election is Chairman and Supervisor 1, Supervisor 2, Clerk and Treasurer
 - i. Open nominations for Chairman
 - ii. Close nominations for Chairman
 - iii. If three or more are nominated for Chairman, conduct a ballot vote and 2 ballot counters count the votes
 - iv. Open nominations for Supervisor 1
 - v. Close nominations for Supervisor 1
 - vi. If three or more are nominated for Supervisor 1, conduct a ballot vote and 2 ballot counters count the ballots
 - vii. Open nominations for Supervisor 2
 - viii. Close nominations for Supervisor 2
 - ix. If three or more are nominated for Supervisor 2, conduct a ballot vote and 2 ballot counters
 - x. Open nominations for Clerk
 - xi. Close nomination for Clerk
 - xii. If three or more are nominated for Treasurer, conduct a ballot vote and 2 ballot counters
 - xiii. Open nominations for Treasurer
 - xiv. Close nominations for Treasurer
 - xv. If three or more are nominated for Treasurer, conduct a ballot vote and 2 ballot counters
11. Ask for motion to destroy paper ballots
12. Notice of Nomination at Caucus Form - distributed to nominated candidates
13. Receipt of Notice of Nomination Form - distributed to nominated candidates
14. Campaign Finance Registration Statement - distributed to nominated candidates
15. Declaration of Candidacy - distributed to nominated candidates
16. Declare Caucus Closed / Adjournment
