Magnificent beauty of the Pocono Mountains make it an ideal destination for a home or vacation getaway, a place for people to escape from the hassles of life. While in recent days, PennDOT roadwork along Locust Ridge Road has

importance of improving appearance at the entrance. "You only have one chance at a first impression," he said. "We re-evaluated parking and grew six spaces!" Embracing this time to revitalize, he told of a feasibility study to also enhance gate two. Considering the potential Orono Drive project as "the next step in improving our

look," he reasoned, "Visitors and homeowners should carry that wow sensation from our gates as they experience the entire community." ALCA board member and veteran, flag raiser for a day Tom Filla agreed, "It was something we needed for a while." "This was money well spent," smiled resident Marcy Lehigh, an Arrowhead resident for more than 50 years. "Things don't last forever."

Seizing the opportunity to further fuel enthusiasm for pre-views while adding past news to the mix, Usbeck later announced ALCA's acquisition of a Marker Advocates of Tobyhanna Township (MATT) Historical Roadside Marker commemorating "The Battle of Locust Ridge." A dedication date is planned at the spot along Locust Ridge and Slutter Road for 1 p.m. this Saturday, September 3.

Emergency notification system changing

In order to better serve the residents and visitors of Monroe County, the Monroe County Office of Emergency Management and Monroe County Control Center are upgrading the current emergency text alert system, ReadyNotify-Monroe, to Monroe County CodeRED. This transition will occur over the next week and may result in current registered users not receiving messages in a timely manner. Delays are not expected to last more than one week. CodeRED is an emergency notification service, funded by the Northeast Pennsylvania Counter Terrorism Task Force, which allows emergency officials to notify residents and

businesses by telephone, cell phone, text message, email and social media regarding time-sensitive general and emergency notifications. Only authorized officials have access to the CodeRED system. The CodeRED database contains information received from public databases, including regional phonebooks.

However, no resident should assume that their information is in the system. If you did not register for ReadyNotifyMonroe, and you would like to receive messages, go to www.monroecountypa.gov/codered and click on the CodeRED logo. You can also download the CodeRED app on your Apple or Android device.

The evening begins at 5 with a cash bar, followed by dinner at 6, and concert at 7:30. Dessert will follow. Tickets, at \$65 per person, include everything except gratuity.

Among the selections to be performed is a rendition of *Close Beside the Crystal Waters*, the Pocono Township High School alma mater.

There will also be a display of the Tannersville Glenwood Hall Band instruments and uniforms.



In partnership with Pocono Medical Center, free A1C diabetes screenings will be provided at Senator Mario Scavello's Pen Argyl District Office on September 13 from 10 a.m. to 2 p.m.

The A1C test is a simple blood test that provides information about a person's average levels of blood glucose, also called blood sugar, over the past three months. Sometimes called the hemoglobin

A1c, HbA1c, or glycohemoglobin test, the A1C test is the primary test used for diabetes management and diabetes research.

"It is important that we all take necessary measures to ensure healthy living. This event offers residents an opportunity to protect their health and I hope everyone who thinks they may be at risk for diabetes catches early signs," Senator Scavello noted.

9/11 15th Anniversary Memorial Ceremony set

The public is invited to attend a 9/11 15th Anniversary Memorial Ceremony at United Way of Monroe County's 9/11 Memorial Garden on September 11 at 1 p.m., rain or shine.

The Ceremony will honor and remember Monroe County residents who lost their lives, were injured or displaced due to the tragic events of September 11, 2001. United Way will also be presenting the newly refurbished 9/11 Memorial Garden, thanks to Erik Cravotta of BSA Troop 300.

Erik is a Life Scout with Troop 300 in Stroudsburg. His mother, Monica Cravotta is Vice president at United Way of Monroe County and through her, he found out that there was a 9/11 Memorial Garden on the property. After 9/11/01, United Way helped the victims and their families access the resources that became available to them. At United Way's Day of Caring, held on 9/11 in 2002, a Memorial Garden was installed to honor those who were lost or injured and to

Edgar Ponce from Tobyhanna heads home from military training

Members of a New York Army National Guard task force with the 27th Infantry Brigade Combat Team successfully completed the rigors of a force on force training exercise in Florida on July 29 and begin heading home this week. The troops, with more than 5,000 participants from more than 30 states across the country, spent nearly the month of July at Fort Polk as part of the training rotation at the Joint Readiness Training Center, known as JRTC.

Their experience included deployment and staging at Fort Polk followed by more than 10 days of offensive and defensive missions in the post maneuver areas against a real opposing force.

The maneuver training is designed to challenge all the components of the maneuver brigade, including infantry, artillery and aviation operations, engineering and reconnaissance tasks, logistics and resupply and medical support and personnel replacements.

The brigade task force included the entire New York Army National Guard brigade combat team, along with supporting elements that included additional infantry units from Massachusetts, Rhode Island and Pennsylvania. Aviation support for the task force included aircrews from Con-

necticut, Maryland and Utah.

1st Sergeant Edgar Ponce from Tobyhanna completed training here as part of the Golf Company (Forward Support Co., Infantry), 427th Brigade Support Battalion and redeploys back home this week as the brigade task force completes the training exercise.

The Joint Readiness Training Center allows Army units to conduct combat training in a realistic environment which features a well-trained opposing force, civilian role-players on the battlefield, high-tech systems which monitor the action, and observer-controllers to evaluate unit actions.

All of the exercise participants and opposing force troops wore the Army's Multiple Integrated Laser Engagement System (MILES) gear for the exercise.

The gear consists of a sensor-lead harness worn by the Soldier and a halo of sensors attached to the Soldier's helmet. In addition to sensors, every weapon system also includes a laser emitter.

When the Soldier fires a blank with their weapon, the laser fires a beam. If a target sensor receives a hit, then the Soldier is considered wounded or a vehicle disabled, requiring all of the combat response actions to

provide first aid and evacuation.

The MILES gear enables infantrymen to conduct realistic combat training against a real enemy opponent and forces combat medics and logistics personnel to hone their skills by treating simulated battle-

field injuries or evacuating damaged vehicles.

JRTC is one of the Army's three combat training centers at which brigade-sized units can conduct realistic training against an opposing force. JRTC specializes in light infantry warfare and operations.

For Soldiers, it is considered by Soldiers as the Super Bowl of Army training.

Joint Resolution 2016-1

Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, reducing the size of the General Assembly.

The General Assembly of the Commonwealth of Pennsylvania hereby resolves as follows:

Section 1. The following amendment to the Constitution of Pennsylvania is proposed in accordance with Article XI:

That section 16 of Article II be amended to read:

§ 16. Legislative districts.

The Commonwealth shall be divided into 50 senatorial and [203] **151** representative districts, which shall be composed of compact and contiguous territory as nearly equal in population as practicable. Each senatorial district shall elect one Senator, and each representative district one Representative. Unless absolutely necessary no county, city, incorporated town, borough, township or ward shall be divided in forming either a senatorial or representative district.

Section 2. (a) Upon the first passage by the General Assembly of this proposed constitutional amendment, the Secretary of the Commonwealth shall proceed immediately to comply with the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania and shall transmit the required advertisements to two newspapers in every county in which such newspapers are published in sufficient time after passage of this proposed constitutional amendment.

(b) Upon the second passage by the General Assembly of this proposed constitutional amendment, the Secretary of the Commonwealth shall proceed immediately to comply with

the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania and shall transmit the required advertisements to two newspapers in every county in which such newspapers are published in sufficient time after passage of this proposed constitutional amendment. The Secretary of the Commonwealth shall submit this proposed constitutional amendment to the qualified electors of this Commonwealth at the first primary, general or municipal election which meets the requirements of and is in conformance with section 1 of Article XI of the Constitution of Pennsylvania and which occurs at least three months after the proposed constitutional amendment is passed by the General Assembly.

Section 3. Upon ratification by the electors, the General Assembly shall enact legislation to implement this constitutional amendment so that it applies for the first time to the first session of the General Assembly which begins after the 2020 reapportionment.

Joint Resolution 2016-2

Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, further providing for exemptions and special provisions.

The General Assembly of the Commonwealth of Pennsylvania hereby resolves as follows:

Section 1. The following amendment to the Constitution of Pennsylvania is proposed in accordance with the provisions of Article XI:

That section 2(b)(vi) of Article VIII be amended to read:

§ 2. Exemptions and special provisions.

(b) The General Assembly may, by law:

(vi) Authorize local taxing authorities to exclude from taxation an amount based on the assessed value of homestead property. The exclusions authorized by this clause shall not exceed **[one-half of the median assessed value of all] 100% of the assessed value of each** homestead property within a local taxing jurisdiction. A local taxing authority may not increase the millage rate of its tax on real property to pay for these exclusions.

Section 2. (a) Upon the first passage by the General Assembly of this proposed constitutional amendment, the Secretary of the Commonwealth shall proceed immediately to comply with the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania and shall transmit the required advertisements to two newspapers in every county in which such newspapers are published in sufficient time after passage of this proposed constitutional amendment.

(b) Upon the second passage by the General Assembly of this proposed constitutional amendment, the Secretary of the Commonwealth shall proceed immediately to comply with the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania and shall transmit the required advertisements to two newspapers in every county in which such newspapers are published in sufficient time after passage of this proposed constitutional amendment. The Secretary of the Commonwealth shall submit this proposed constitutional amendment to the qualified electors of this Commonwealth at the first primary, general or municipal election which meets the requirements of and is in conformance with section 1 of Article XI of the Constitution of Pennsylvania and which

occurs at least three months after the proposed constitutional amendment is passed by the General Assembly.

Joint Resolution 2016-3

Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, further providing for exemptions and special provisions.

The General Assembly of the Commonwealth of Pennsylvania hereby resolves as follows:

Section 1. The following amendment to the Constitution of Pennsylvania is proposed in accordance with Article XI:

That section 2(b) of Article VIII be amended by adding a paragraph to read:

§ 2. Exemptions and special provisions.

(b) The General Assembly may, by law:

(vii) Permit a city of the first class to impose taxes for the benefit of the city of the first class on real estate used for business purposes at a tax rate that exceeds the tax rate applicable to other real estate, in accordance with the following:

(A) So long as a rate variance is in effect, the combined rate of taxes on real estate used for business purposes imposed by the city of the first class or authorized by the city of the first class for its school district shall not vary by more than fifteen percent from the combined rate of taxes on other real estate imposed or authorized by the city of the first class.

(B) The General Assembly shall require the city of the first class to reduce the aggregate revenue from other taxes imposed for the benefit of the city of the first class both on businesses and any wage and net profits tax by the amount of any real estate tax revenues attributable to the variance.

Section 2. (a) Upon the first passage by the General Assembly of this proposed constitutional amendment, the Secretary of the Commonwealth shall proceed immediately to comply with the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania and shall transmit the required advertisements to two newspapers in every county in which such newspapers are published in sufficient time after passage of this proposed constitutional amendment.

(b) Upon the second passage by the General Assembly of this proposed constitutional amendment, the Secretary of the Commonwealth shall proceed immediately to comply with the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania and shall transmit the required advertisements to two newspapers in every county in which such newspapers are published in sufficient time after passage of this proposed constitutional amendment. The Secretary of the Commonwealth shall submit this proposed constitutional amendment to the qualified electors of this Commonwealth at the first primary, general or municipal election which meets the requirements of and is in conformance with section 1 of Article XI of the Constitution of Pennsylvania and which occurs at least three months after the proposed constitutional amendment is passed by the General Assembly.

Blazing new Jackson Township trail for hiking series

For nine years, 175 acres of open space on Sherwood Forest Road in Jackson Township have remained unmapped and mostly unexplored – until now.

Saylorsburg teen Ambrose Cavalier has scoped out a trail network by linking overgrown roads using satellite images, Google Maps, GPS, and other mapping tools.

At 10 a.m. Saturday, September 24, Get Outdoors Pocono hiking series participants will use his trail map to discover the land now called Sherwood Forest Greenway.

Once a farm and then a proposed site for housing development (an idea abandoned after a few access roads were cut), the land became part of the Monroe County Open

Space program in 2007. Since then, Mother Nature has reclaimed her own.

A woods walk – mostly beech, with oaks, maple, and some white pine and hemlocks, too – leads past a sturdy stone row and uphill through a leafy, dark green tunnel of arching beech saplings. At the summit – 1,125 feet up – participants get their reward: views of Delaware Water Gap to the left, Wind Gap to the right, a glimpse of Palmerton Gap and long vistas of Camelback and state gamelands.

As required by Article XI, Section 1 of the Constitution and statutory law, the Secretary of the Commonwealth caused the proposed amendment to be advertised in 2014 and 2016.

Pursuant to the original joint resolutions, the proposed amendment was to be submitted to the electors of Pennsylvania at the General Primary to be held on April 26, 2016. However, on April 12, 2016, the General Assembly passed H.R. 783, a concurrent resolution that directed the Secretary of the Commonwealth to remove the proposed amendment from the General Primary ballot and to place the proposed amendment on the General Election ballot in November 2016.

The Secretary of the Commonwealth, therefore, has once again caused the proposed amendment to be published here, in anticipation of the General Election. In accordance with the mandate of H.R. 783, the Secretary of the Commonwealth will submit the proposed amendment to the electors of Pennsylvania in the form of a ballot question at the General Election to be held on November 8, 2016. If a ballot question is approved by a majority of electors voting on it, the corresponding amendment becomes part of the Constitution.

Those parts of the joint resolution that appear in **BOLD PRINT** are the words of the Constitution that are proposed by the General Assembly for addition or deletion. JOINT RESOLUTION 2015-1

Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, further providing for compensation and retirement of justices, judges and justices of the peace.

The General Assembly of the Commonwealth of Pennsylvania hereby resolves as follows:

Section 1. The following amendment to the Constitution of Pennsylvania is proposed in accordance with Article XI:

That section 16(b) of Article V be amended to read:

§ 16. Compensation and retirement of justices, judges and justices of the peace.

(b) Justices, judges and justices of the peace shall be retired on the last day of the calendar year in which they attain the age of **[70] 75** years. Former and retired justices, judges and justices of the peace shall receive such compensation as shall be provided by law. Except as provided by law, no salary, retirement benefit or other compensation, present or deferred, shall be paid to any justice, judge or justice of the peace who, under section 18 or under Article VI, is suspended, removed or barred from holding judicial office for conviction of a felony or misconduct in office or conduct which prejudices the proper administration of justice or brings the judicial office into disrepute.

(a) Upon the first passage by the General Assembly of this proposed constitutional amendment, the Secretary of the Commonwealth shall proceed immediately to comply with the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania and shall transmit the required advertisements to two newspapers in every county in which such newspapers are published in sufficient time after passage of this proposed constitutional amendment.

(b) Upon the second passage by the General Assembly of this proposed constitutional amendment, the Secretary of the Commonwealth shall proceed immediately to comply with the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania and shall transmit the required advertisements to two newspapers in every county in which such newspapers are published in sufficient time after passage of this proposed constitutional amendment. The Secretary of the Commonwealth shall submit this proposed constitutional amendment to the qualified electors of this Commonwealth at the first primary, general or municipal election which meets the requirements

of and is in conformance with section 1 of Article XI of the Constitution of Pennsylvania and which occurs at least three months after the proposed constitutional amendment is passed by the General Assembly.

PROPOSED CONSTITUTIONAL AMENDMENT AMENDING THE MANDATORY JUDICIAL RETIREMENT AGE Ballot Question

Shall the Pennsylvania Constitution be amended to require that justices of the Supreme Court, judges, and magisterial district judges be retired on the last day of the calendar year in which they attain the age of 75 years?

Plain English Statement of the Office of Attorney General

The purpose of the ballot question is to amend the Pennsylvania Constitution to require that justices, judges and justices of the peace (known as magisterial district judges) be retired on the last day of the calendar year in which they attain the age of 75 years.

Presently, the Pennsylvania Constitution provides that justices, judges and justices of the peace be retired on the last day of the calendar year in which they attain the age of 70 years. Justices of the peace are currently referred to as magisterial district judges.

If the ballot question were to be approved, justices, judges and magisterial district judges would be retired on the last day of the calendar year in which they attain the age of 75 years rather than the last day of the calendar year in which they attain the age of 70 years.

This amendment to the mandatory retirement age would be applicable to all judges and justices in the Commonwealth, including the justices of the Pennsylvania Supreme Court, judges of the Commonwealth Court, Superior Court, county courts of common pleas, community courts, municipal courts in the City of Philadelphia, and magisterial district judges.

The ballot question is limited in that it would not amend any other provisions of the Pennsylvania Constitution related to the qualification, election, tenure, or compensation of the justices, judges or magisterial district judges.

The effect of the ballot question would be to allow all justices, judges, and magisterial district judges to remain in office until the last day of the calendar year in which they attain the age of 75 years. This would permit all justices, judges, and magisterial district judges to serve an additional five years beyond the current required retirement age.

Blakeslee United Methodist Church dedicates marker

The congregation first met in a log schoolhouse in 1840. After 176 years, the Blakeslee United Methodist Church is the oldest congregation in Tobyhanna Township. In celebration of this milestone, the members gathered after their church service this past Sunday, August 28, to dedicate a historical roadside marker honoring their sustained faith.

To survive all that has taken place and changed these past 176 years is remarkable. And the current church building itself has been standing for almost 120 years, surviving storms that toppled its steeple and the moving of the entire building to accommodate the widening of the highway.

Seventeen stained glass windows document the history of the congregation's founders and leaders, many represented today by members who are descendants of those early congregants.

The Rev. Joseph Healey introduced Gene Kerrick, who presented the history of the

church to the congregation and guests. Gene subsequently unveiled the historical roadside marker, which was donated by the Kings Daughters of the Blakeslee UMC. The Marker Advisors of Tobyhanna

Keeping the Rubber Side Down ...
