7 reimbursement of towing or storage fees I have already paid.

8 I believe that that the towing or immobilization of my vehicle was illegal, and therefore I am  
9 proceeding with this action pursuant to NRS 487.039.

10 Although I have demanded that Authorizing Defendant pay the outstanding towing and  
11 storing costs or the outstanding costs for removing the immobilization device, Authorizing  
12 Defendant has failed to pay the outstanding balance due.

13 Based upon the above, I request an Order from the Court as follows:

- 14 1. Finding that the towing or immobilization of my vehicle was unlawful; and  
15 2. Ordering Authorizing Defendant to pay (*insert an amount less than or equal to*  
16 *\$15,000*) \$ \_\_\_\_\_, which represents the towing and storage costs or the costs for  
17 removing the immobilization device related to this incidence; and  
18 3. Ordering the towing or immobilization company to release the vehicle to me  
19 immediately or remove the immobilization device immediately.
