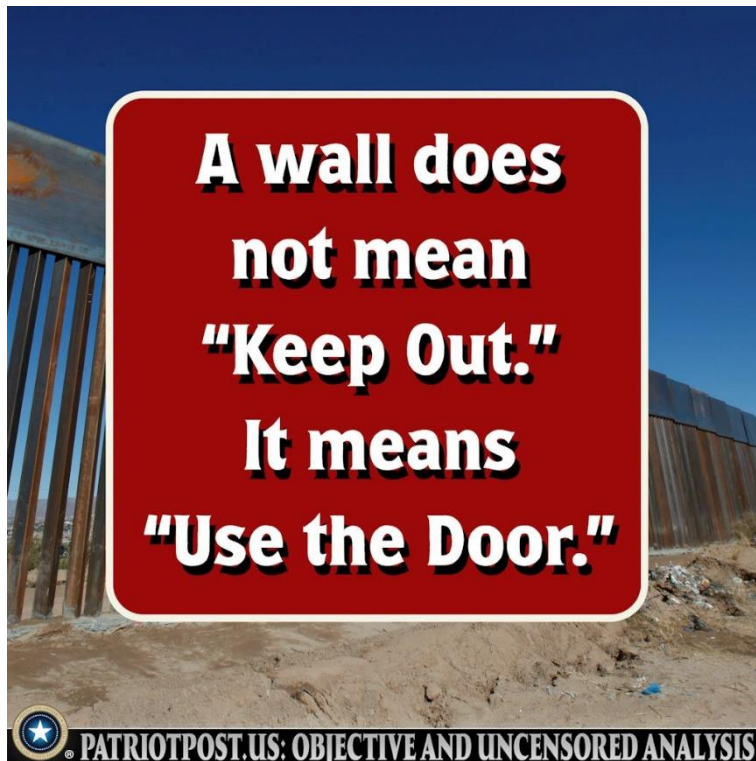

"DHS Revokes Parole for Aliens Who Entered Through the CBP One App"

Last week, the Department of Homeland Security [sent notices](#) to parolees who entered through the CBP One app, informing the aliens that their parole will soon be revoked and that they will be subject to deportation. The notices, sent via email, also urged the aliens to self-deport “immediately” using the same app, which has now been repurposed and renamed “[CBP Home](#).”

The CBP One app was launched in January 2023 by the Biden administration to facilitate the mass importation of illegal aliens. Through the app, aliens who were inadmissible were nevertheless [invited](#) to enter the U.S. and apply for asylum and parole. [The revocation of parole is expected to apply to over 900,000 aliens](#). However, some of the aliens who received parole through the CBP One app were able to obtain other avenues to stay in the U.S., such as Temporary Protected Status or asylum.

The Department of Homeland Security (DHS) [confirmed](#) the cancellation of parole, stressing that Homeland Security Secretary Kristi Noem has “full authority” to do so. “Canceling these paroles is a promise kept to the American people to secure our borders and protect national security,” DHS added. “Formal termination notices have been issued, and affected aliens are urged to voluntarily self-deport using the CBP Home App. Those who refuse will be found, removed, and permanently barred from reentry.”

Once again, news outlets such as the [Associated Press](#), [CBS News](#), and [PBS](#) incorrectly reported last week that DHS had cancelled the “legal status” of these aliens who had entered the U.S. via parole. Their reporting either ignorantly or willfully misrepresents what parole is. As set forth in statute ([INA 212\(d\)\(5\)](#)), parole does not provide aliens with legal status; it does not constitute a lawful admission. Parole merely permits inadmissible aliens to enter the U.S. temporarily for a specific purpose, despite the fact that they have no legal status. While in the U.S., these aliens remain illegal aliens (despite the fact that they are given work authorization) until they obtain legal permission to stay. This may be by receiving asylum or a work or family-sponsored green card.

Just two weeks ago, the Trump administration announced it was also [revoking parole](#) for over 500,000 aliens who had received it through the Cuba, Haiti, Nicaragua, Venezuela (CHNV) parole program. A federal judge last week [blocked](#) DHS’s revocation of parole, which was set to take place on April 24. The Department of Homeland Security, however, argues it is well within its authority to revoke the parole of aliens. That litigation remains ongoing.

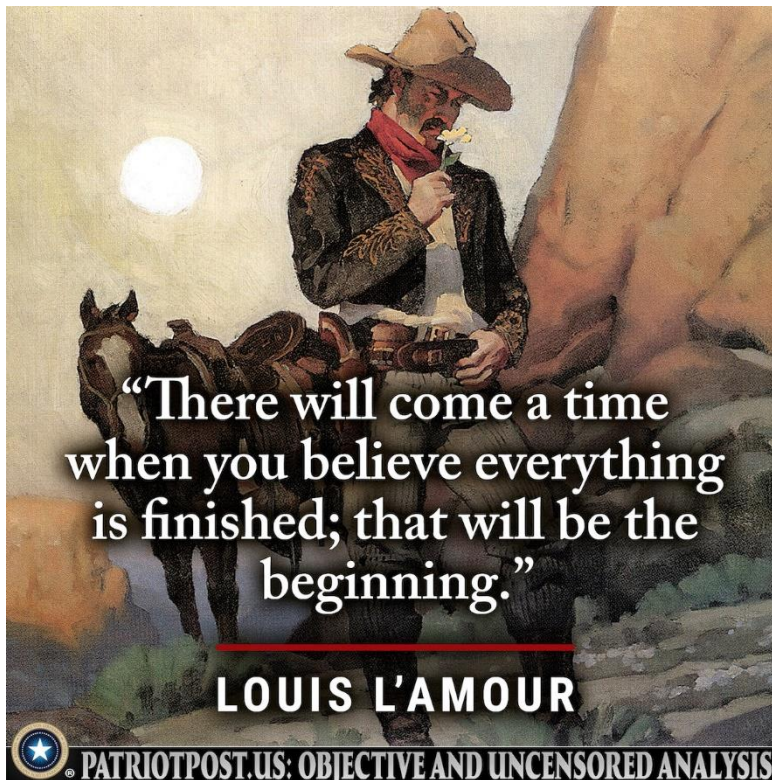

Alien Registration Requirement (ARR) - Spread the Word!

On Jan. 20, 2025, President Trump issued the [Protecting the American People Against Invasion](#) executive order which directed the Department of Homeland Security to ensure that aliens comply with their duty to register with the government under section 262 of the Immigration and Nationality Act (INA) (8 U.S.C. 1302), and ensure that failure to comply is treated as a civil and criminal enforcement priority.

The INA requires that, with limited exceptions, all aliens 14 years of age or older who were not fingerprinted or registered when applying for a U.S. visa and who remain in the United States for 30 days or longer, must apply for registration and fingerprinting. Similarly, parents and guardians must ensure that their children below the age of 14 are registered. Within 30 days of reaching his or her 14th birthday, the previously registered alien child must apply for re-registration and to be fingerprinted.

Once an alien has registered and appeared for fingerprinting (unless waived), DHS will issue evidence of registration, which aliens over the age of 18 must carry and keep in their possession at all times.

It is the legal obligation of all unregistered aliens (or previously registered children who turn 14 years old) in the United States to comply with these requirements. Failure to comply will result in criminal and civil penalties, up to and including misdemeanor prosecution and the payment of fines.

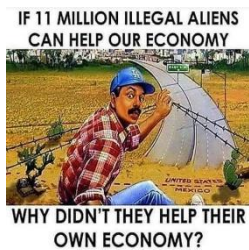
