SPLC lost its way many, many years ago (lack of minority civil rights violations) but it still has that "hunting dog" ability to sniff out cash donations from clueless donors. I wonder if SPLC continues to maintain tax haven accounts in the Cayman Islands? But I digress.

Maryland elected officials of a certain political mindset, and their overly aggressive, highly taxpayer compensated (federal, state and local), non-government organization (NGO) partners have different goals and objectives than hard working, law-abiding Maryland citizens. Together these public/private sector leeches have

instituted an interconnected network of programs and services to attract and sustain illegal aliens and their families in our cities, towns and communities, citizens be damned.

You are familiar with most of the groups, all jockeying for a piece of the action - Casa of Maryland, Catholic Charities, Lutheran Immigration and Refugee Service, Gilcrest Immigrant Resource Center, Identity Inc, CAIR, Asian Pacific American Legal Resources Center, Ayuda, etc., etc. Many of these groups possess a double-edged machete, with one edge used to "slice their portion" of funds from the taxpayer funded pie. The other edge is to lobby against federal, state, and local legislation which could endanger their illegal alien clientele, and ultimately their organization's lifeblood funding. Over the years, HSM has testified (in the minority of course) against dozens of these groups in Annapolis and at local hearings.

While common knowledge to HSM supporters, it took the lawlessness of the Biden/Harris wide open borders, and the deluge of 15 million plus illegal aliens flowing into the U.S. over the last four years to actually awaken Americans.

**What Sounded the Alarm about Illegals in Maryland?**

Overcrowd Public Schools? - Not a problem, just hire more Spanish speaking teachers to the point where many elementary schools in Montgomery County, for example are now taught part or all day in Spanish, whether your kids want it or not. Have your kids sit on the floor as classrooms are bursting with uninvited students. End focus on advanced classes and programs for local kids falling behind as resources are needed for our new guests. Falling test scores? Just modify those racist, anti-immigrant standardized tests and scores will be equalized across the board.

In-State college tuition for illegals continues to cost taxpayers a bundle each year and its rising. So does it matter when our some of kids are denied admission when college seats are maxed out? Maryland Colleges are supposed to report in-state illegal alien student enrollment each year to Annapolis. I can assure you the enrollment is well beyond the "dozens" CASA of Maryland testified to Maryland elected officials when the in-state tuition legislation was first proposed.

Financially Failing Hospitals? - Long waits in hospital emergency rooms? Ok, lets put serious medical clinics in every public elementary, middle and high school in Montgomery County for illegal aliens and their families in hopes illegals will stop going to emergency rooms (no such luck). And don't try to get your kids an appointment at those school clinics, as they ain't for you. Paying for the cost of birthing illegal alien babies (Anchor Babies) also floods our hospitals with more unwanted customers, and eventually our schools with more non-English speaking students.

The Montgomery County Planning group noted that Hispanics went from 11% of County population in 2010, to 20% of population in 2021. 23% of the 2021 population was ages 5-17. Can you imagine what those percentages will be when the Biden/Harris illegal alien tsunami numbers through 2024 are filtered in??

Criminal Aliens Wanted by Federal ICE for Deportation in Local Jails? - Sorry ICE, multiple Maryland Counties and Baltimore City hustle the criminal aliens out the side door and back onto our streets, regardless of their crime. Good luck finding them with NGO's and politicians hiding their tracks and providing personalized electronic warning systems regarding ICE raids.

And yes, crime, break-ins, vandalism, and rapes are up in Maryland. Hiding the full detailed crime statistics from the Public doesn't work anymore. Same with not reporting crimes or removing details of the crime/criminal photos so illegal aliens don't dominate the stats. Our public school officials seemingly follow in the footsteps of our politicians, and are quite forgetful in reporting assaults, drug use, gang violence, and others crimes in our schools. And of course, they also neglect to document publicly the race and immigration status of those responsible for the crimes.

**Please Note:** "MS-13", the premier Maryland illegal alien gang from Central America, resident in our public schools and communities (especially Prince George's and Montgomery counties), has been named a "Terrorist Organization" by the Trump Administration. Do MS-13 members still qualify for housing assistance, food stamps, drivers' licenses, CASA of Maryland welcome center services, and Identity Inc counseling sessions?

**Not Enough Housing, Food Stamps, Energy, Social Services, Jobs, etc. for our "guests"?** Use whatever funds are allocated for the needs of citizens and instead use it for illegal aliens and their families. It's that simple. Funny how housing codes are not enforced for single family homes when loaded to the brim with "multiple immigrant families" and their multiple cars and kids clogging our streets and public schools. Can't get the funds together for a mortgage down payment? No worries, illegals are provided with mortgage assistance, same for job opportunities, car and business loans, and more by taxpayer funded organizations.

It is ironic to me how many in Baltimore's black community for example, continue to push for slavery "reparations", yet primarily non-black illegal aliens in Baltimore are effectively getting their undeserved "reparations" right now! The black mayor and city council, with support from our black governor, have no problem with funding housing and mortgages, jobs, food stamps, car and business loans, and more for illegals.

**Employment** - We were told illegals were "picking and harvesting" our food, and we would perish without their thankless labor! In Montgomery County, Maryland only 171 immigrants were employed in farming, fishing and forestry (2021). They seemed to "pick and harvest" (pardon the pun) different employment paths like transportation, personal care, material moving, food preparation, and more - over 75 thousand jobs and state-wide nearly 300 thousand. Don't Americans hold those type of jobs too? Or have they been displaced?

According to the Bureau of Labor Statistics, for the past 6 years, immigrants took 90 percent of the new jobs created in the U.S. (4.7 million). U.S. born employment was just up 645 thousand over the same period.

And in multiple U.S. locations, some really hard working Chilean illegals, who must have been fruit pickers in the homeland due to their tremendous skill sets, actually "picked higher value crops" here in America. They robbed the mansions of rich sports players, picking up jewelry and cash, and whatever else they could carry!

**Voting Rights and Citizenship?** I don't recall those same persuasion of politicians promoting these rights for the black community back in the day. But they are working hard right now to give these rights to illegal aliens. And are rushing to turn these "uninvited guests" and their offspring into voting citizens faster than you can say "Ole" (bravo!). Every vote counts, some even multiple times. Doesn't that water down the value of our votes?

Don't forget, that any of the 25 million+ Illegal Aliens remaining in the Country over the next 6 years will be counted in the 2030 Census! Adding legislative strength and federal resources to regions that don't deserve it.

## **Alien Registration Requirement (ARR) - Spread the Word!**

On Jan. 20, 2025, President Trump issued the [Protecting the American People Against Invasion](#) executive order which directed the Department of Homeland Security to ensure that aliens comply with their duty to register with the government under section 262 of the Immigration and Nationality Act (INA) (8 U.S.C. 1302), and ensure that failure to comply is treated as a civil and criminal enforcement priority.

The INA requires that, with limited exceptions, all aliens 14 years of age or older who were not fingerprinted or registered when applying for a U.S. visa and who remain in the United States for 30 days or longer, must apply for registration and fingerprinting. Similarly, parents and guardians must ensure that their children below the age of 14 are registered. Within 30 days of reaching his or her 14th birthday, the previously registered alien child must apply for re-registration and to be fingerprinted.

Once an alien has registered and appeared for fingerprinting (unless waived), DHS will issue evidence of registration, which aliens over the age of 18 must carry and keep in their possession at all times.

It is the legal obligation of all unregistered aliens (or previously registered children who turn 14 years old) in the United States to comply with these requirements. Failure to comply will result in criminal and civil penalties, up to and including misdemeanor prosecution and the payment of fines.
