### "Mexican Government Offers Finabien Card for U.S.-Resident Mexicans to Avoid Remittance Tax"

### **Organizations Supporting Illegal Aliens**

#### CASA of Maryland

We have reviewed CASA many times before, but let's give them a fresh look in light of President Trump signing the "Big Beautiful Bill" into law. You would think that CASA has a few English speakers/readers on their staff who would have noticed that the Administration is about to supersize ICE and the Border Patrol. That guarantees more Federal enforcement activities in Maryland, especially since our state is an illegal alien sanctuary for all intents and purposes.

On top of that, CASA lost recently lost a major Supreme Court decision 6-3 regarding the rights of lower federal courts to issue nation-wide rulings against activities created by the Executive Branch. CASA's legal arguments,

as well as the questionable points raised by Justice Brown, were blown out of the water by the decision. How embarrassing for CASA and the legacy of now former CASA leader Gustavo Torres.

So with two major events going massively against CASA's core mission, why you ask, is CASA still pushing the "Hiring of Migrants" from its multiple Day Laborer Centers in Maryland? Don't think the vastly beefed up ICE is going to review this hiring scam operation, which has been underway since Ike Leggett occupied the MoCo County Executive position over 20 years ago? Ike originally approved and funded this scam operation.

The CASA "Worker Agreement Form" is classic. It gets signed Only by the "employer" and the "migrant", and payment is handled by those two parties as well.

But its the fine print on the form that deserves most attention. CASA just "Connects" folks and is NOT part of the agreement. Is that like referring a friend to a drug dealer but not paying for or handling the drugs? The form reads:

"I have read and reviewed this Employment Agreement in its entirety. By signing this Agreement, I agree to fully comply with each of the terms and conditions set forth above. I understand that CASA is a social service agency that connects people looking for work with people looking to hire and that CASA is not an employment agency or the employer. I understand by hiring workers through CASA, I am assuming the role of employer. I understand that it is my responsibility to pay any individual that I hire through this social service, whatever wage has been agreed upon to do the job. Furthermore, I understand that my insurance (homeowner or worker's compensation) is responsible for any work related injury that may arise as a result of hiring an individual through this service."

And in even much, much smaller print at the bottom of the form, CASA states it does NOT verify the documents of the "Migrant" for the employer. How convenient, frankly lawless, and utterly dangerous for our Community!

"- CASA does not participate in the verification of documents for employment -  
CASA's participation in this negotiation is strictly as a facilitator between the two parties involved in this agreements. CASA is not a party to this agreement."

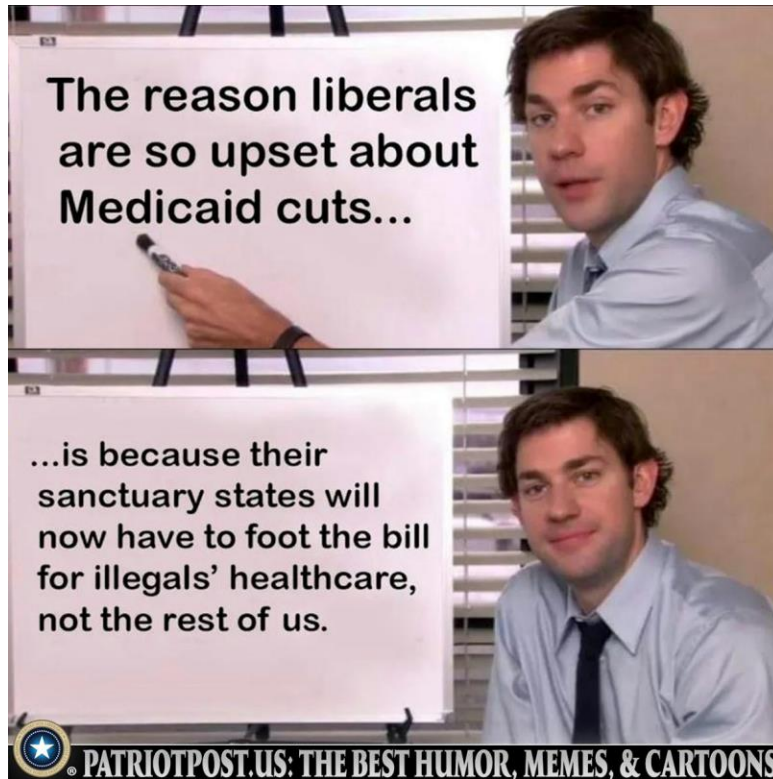

### Alien Registration Requirement (ARR) - Spread the Word!

On Jan. 20, 2025, President Trump issued the [Protecting the American People Against Invasion](#) executive order which directed the Department of Homeland Security to ensure that aliens comply with their duty to register with the government under section 262 of the Immigration and Nationality Act (INA) (8 U.S.C. 1302), and ensure that failure to comply is treated as a civil and criminal enforcement priority.

The INA requires that, with limited exceptions, all aliens 14 years of age or older who were not fingerprinted or registered when applying for a U.S. visa and who remain in the United States for 30 days or longer, must apply for registration and fingerprinting. Similarly, parents and guardians must ensure that their children below the age of 14 are registered. Within 30 days of reaching his or her 14th birthday, the previously registered alien child must apply for re-registration and to be fingerprinted.

Once an alien has registered and appeared for fingerprinting (unless waived), DHS will issue evidence of registration, which aliens over the age of 18 must carry and keep in their possession at all times.

It is the legal obligation of all unregistered aliens (or previously registered children who turn 14 years old) in the United States to comply with these requirements. Failure to comply will result in criminal and civil penalties, up to and including misdemeanor prosecution and the payment of fines.


