**"Governor Moore Signs Law Banning ICE 287g Cooperation"**

Gov Moore on February 17, signed legislation to prohibit state and local jurisdictions from deputizing officers for partnering with federal immigration enforcement as part of the ICE 287g program. ICE cooperation can vary from notifying ICE to pickup illegals in custody in 48 hours (by responding to ICE detainers), to being fully deputized which allows local law enforcement to detain and arrest illegals out in the field.

I can only guess this was done by Moore under national and local peer pressure from his party, radical leftist groups, and local promoters of illegal immigration like CASA of Maryland. Moore pictures himself as future Presidential material. Make no mistake however, this was not done for common sense public safety reasons for Maryland citizens.

This lawless legislation impacts nine counties with ICE agreements/cooperative policies: Cecil, Frederick, Harford, Allegany, Carroll, Garrett, St. Mary's, Wicomico, and Washington.

**"Protect Maryland Values"**, by falsely stating our citizens have no problem with illegals using our: taxpayer funded services, welfare, food stamps, housing, energy, while taking our jobs, overcrowding our schools and bankrupting our hospitals, causing insurance rates to rise

unnecessarily, illegally voting, being counted in the 2030 Census (more bodies, more Congressional seats), gang violence, drugs and human trafficking, abuse of limited of law enforcement and criminal justice resources, and correction facilities?

But wait, Moore seems to be playing both sides of the street (wink, wink) with his recent confusing correspondence to county jurisdictions. The letter says ICE basically violates the Constitution, but what the heck, work with them when you can! Moore as expected does not understand immigration law. Neither it seems do many Federal judges overturned by Appellate Courts around the country, and of course the Supreme Court (see Supreme Court article below).

"Sheriff Albert of Washington County was among many to receive a Feb. 17 letter from Moore's office about the new law, a letter addressed to local leaders that Albert said left him with "kind of a mixed message" from the governor's office.

The new law abolishes the 287(g) agreements in Maryland, but the governor's letter tells law enforcement to cooperate with ICE when they can, Albert said.

The letter signed by Moore, in part, reads:

"In recent weeks, we have seen in real time how federal immigration enforcement is failing to make our communities safer and follow the rule of law. We have also witnessed a deep lack of accountability from the federal government — their actions do not align with the Constitutional policing that we practice and honor in the State of Maryland.

"I am equally troubled by the federal government's lack of focus on violent offenders in its apparent pursuit of arbitrary immigration quotas — in Maryland, the majority of individuals arrested by ICE have never been convicted or even charged with a crime. Of those with convictions, most have been for minor offenses.

**“Public safety is, has been, and will continue to be my top priority. Therefore, I want to be clear:**

- **SB 245/HB444 does not prevent the State or localities from continuing to work with the federal government on our shared public safety priorities, including the removal of non-citizen offenders who pose a risk to public safety;**
- **Nothing about the law changes your ability to work with the federal government on criminal investigations and joint task forces unrelated to civil immigration enforcement, nor does the law authorize or require the release of dangerous criminals;**
- **The law does not prevent localities from continuing to notify ICE about the impending release of an individual of interest from local custody or coordinating the safe transfer of custody within constitutional limits; and**
- **“Anyone who is charged with a crime under State law must go through the State criminal process and, if convicted, must serve their sentence.”**

**Moore, in the letter, also directs Public Safety and Correctional Services Secretary Carolyn Scruggs to continue the department’s “lawful coordination with ICE on the removal of public safety threats and I encourage each of you to do the same with your personnel.”**

**Bottom Line - We note that Moore and many of his compatriots can't seem to grasp federal law in that any and all immigrants in the country illegally can be detained, arrested and deported. Not just those that have already committed rapes, murders and crimes against our citizens and communities. Stop your neo-Confederate policies of defending lawless immigrants and their families who have no moral or legal right to be in our country.**

**The U.S. allows approximately one million legal immigrants in every year. There is a system in place to be screened and vetted, and immigrants wanting to be future Americans actually use it.**

**Let's focus on assimilating legal immigrants so they understand our History, Culture and English language. Wasting our tax dollars on uninvited, unvetted, unemployed, uneducated, unhealthy, non-English speaking aliens is a poor use of our tax dollars.**

### "Maryland sees drop in Hispanic graduations as immigration raids ramp up"

Let's assume the stats below are correct and Hispanic students are dropping from the Maryland school population. Could it be illegal alien Hispanic (and other) families are taking advantage of free DHS flights home and the \$2,000 per person for leaving the country (with future ability to come back)? Or are they self-deported on their own to avoid ICE arrest? Three million non-citizens have left the U.S. voluntarily or with "help" since January 2025.

Is this actually a problem?? In Montgomery County citizens pay over \$17K per student per year for student K-12 education (even more in Baltimore City). Additional costs for non-English speakers and those on free meals must be added in. More students forces the County to hire more teachers especially for non-English speakers as well as build new or remodel older public schools to handle the increase in students. Some schools in MoCo have gone all Spanish despite a sizeable portion of non-Hispanics in the school! Obviously, less students and related costs are a blessing for all Maryland taxpayers.

**"State education officials have anecdotal evidence that Trump's policies and deportations have played a role in a 4.4% drop in the Hispanic graduation rate and a 5.5% drop for English learners."**

**"These significant declines are notable. Heightened political tensions and fear around immigration enforcement erode students' sense of safety and belonging, disrupting learning and pathways to graduation," Maryland Board of Education President Josh Michael said."**

**Why is Josh Michael getting involved in the illegal immigration issue? Nervous school budgets and teacher union payrolls will be cut as student populations decline? Michael and the BOE should be focusing 24/7 on declining student test scores in reading, writing and arithmetic.**

**Stopping ICE from cooperating with County Law Enforcement around the state will INCREASE the number of ICE Agents on our streets making arrests of illegals. Did our legislators like State Senator Will Smith from MoCo or House Speaker from PG Joseline Pena-Melnyk think that maybe stopping ICE cooperation in jail facilities would further impact Hispanic and other illegal alien students in our public schools? Not a chance. Our politicians would rather create a Minneapolis type environment where leftist rioters will interfere with ICE operations.**

**"Canceling/Delaying ICE Facilities and More in Maryland"**
